EVOLUTIVITY AS AN EXISTENTIAL CHARACTERISTIC OF COLONIALISM

- a fragment of the hypothesis “Did capitalism definitely kill the West?”

“Truth comes into the world as heresy,
and leaves as a delusion “

Abstract:

It is interesting that little is said about colonialism and its manifestations and consequences, and even less is written. One gets the impression that the topic has been overcome, studied and rejected, or maybe someone is intentionally sweeping it under the rug. This paperwork is a modest attempt to systematize the data into a methodological unit and consider them on the basis of the objective consequences they leave. Aware of the fact that this is a huge matter, by considering the basic principles, we tried to reduce the amount of processed material and as much as possible, not to the detriment of the quality of work. It is an attempt to get to the essence of the studied matter through the revealing the key issues in this process. The paperwork is based on the phenomenological model of the evolution of colonialism and the spread of financial colonialism, as its fourth developmental stage, recognized and described by a certain line of thinking. The next question that arises in itself is - is there a next, the fifth stage of colonialism and what is it reflected in? Certainly these are the cryptocurrencies and hidden intentions of those who designed them, it is an imaginary world of finance, virtual and virulent, capable of collapsing in a desired time perhaps in thousandth part of a second and making poor all those who naively believed in its correctness, revolutionaries' and effectiveness. This work is a modest individual attempt of

the author to find the meaning where it hasn't been at a glance, and primarily from a personal perspective.

BASIC TERMS

“The only thing which we wanted for our country is the right to a worthy life, to dignity without pretence, to independence without restrictions... The day will come when history will speak.”¹

Not all conflicts can be called war. Some nations and their states disappeared from the face of the Earth, even though the war was not formally declared to them, because (their) elites did not realize on time that a certain form of conflict was being waged against them, that is, because they did not realize that in someone’s heads and secret plans they have been declared enemies and thus their destiny was predestined. It is a common opinion that wars can be fought only by nations and states, but it has been overcome since the 17th century and the era of the British East India Company, and this fact is confirmed by events on the international scene in the last two decades of the 20th and 21st centuries. Recall that the British East India Company was founded in 1600 by a royal charter, and in 1670 it was given the right by King Charles II to: sell out his money, occupy territories, command fortresses and the army, create alliances and declare war and peace (underlined by the authors). It had an exclusive monopoly of trade (salt, spices, tea, opium, etc.) with China and the transport of goods from and to Europe. Soon, in order to counter the British, but also the Spanish, the French, the Portuguese and the Dutch, in 1602, by uniting several trading houses, they founded their Dutch East India Company (Dutch: Verenigde Oostindische Compagnie, VOC), which monopolized trade in the Indian and Pacific Oceans and operating with China, Japan, Indonesia and Ceylon. Including the strategy of organized piracy, these are the technological embryos of what today in the literature is called the technique of indirect warfare or the strategy of hybrid wars. Let’s go back in history. After the battle of Plassey in 1757, in which the employees of the British company defeated the Indians, this company became a military and trading power on the Indian subcontinent and remained so until 1857. At the peak of its military power, the company had a personal army of 158,500 soldiers and officers in order to realize the financial interests of its private owners. Hundreds of thousands of colonized artisans and their families have gone bankrupt financially as a result of monopolization, unreasonable tax increases and forced sales of their products to British buyers at minimal prices. Due to this nasty private rule of the region, only during 1770 and the “Bengal famine”, every third inhabitant of Bengal died. It is estimated

that from 7 to 10 million of them died. The famine caused by the administration of this company appeared in the period 1780 - 1790, again bringing the death of several million people. It is estimated that in just one century of governing India, the British, through the mentioned company, intentionally caused the death of over 40 million people! Let us recall the fact that India at that time had a developed textile, shipbuilding industry and some other branches. The British formally ordered ships from them for their private navy to protect their own merchant ships. By getting warships, (later called the East Indian Company Flotilla, which they never paid for) they destroyed the Indian Navy, and then, by blocking trade ports, stopped the export of textiles and other goods, thus destroying the Indian textile industry. In this way, as early as 1760, India was transformed from an exporter of finished industrial products into an exporter of raw materials (silk, tea, cotton, indigo, opium, etc.) and a major importer of finished products from the United Kingdom. It is the main part of the very often silent prehistory about the origin of Manchester, in the sense of the world-famous industrial center. The negative connotations of organized drug trafficking (representatives of the Company sold Opium Free Trade Agreements) of its monopoly, the tendency to enrich individuals and neglect the interests of other nations and neighboring countries, affected not only the British Empire, but also Europe and the United States. The monopolistic practice in the USA in 1773 led to the famous "Boston Tea Party" and the war for the independence of the USA. In addition to the opium trade and the wars with China, for that reason in 1839-1842 and 1856-1860, (one of the consequences was the occupation of Hong Kong) the company also fought a dozen wars with regional rulers. The death toll of the Indian subcontinent and material destruction have never been determined. After the rebellion of the Company's soldiers, there was an Indian Rebellion in 1856, after which the United Kingdom took over the Company's property for the following year and ruled them for almost another century, until the formal liberation from colonial rule in 1947, although the Company was formally dissolved in 1874. Essentially, colonial rule has only been modified, evolved, and survived to this day through other technologies. According to the conclusions of the First World War, the United Kingdom ruled every fifth square kilometer of the land on the planet at the beginning of the 20th century, and at that time every fourth inhabitant of the planet paid tribute to it.

Classical colonialism is conceptually defined as the expansion of the sovereignty of a developed and powerful state by establishing dependent territories, whereby the occupied indigenous population is placed under its administrative authority

or emigrated from the occupied territory. Since its inception, it has been the rule of technologically developed countries over the rest of the world. The fact is that every colonizer throughout history completely deprives the colonized of the possibility of independent development, because development is managed by foreigners formally guided solely by personal and group interests, which are publicly declared as economic, military or financial interests of the mother country, although they do not have to be. Since 1953 and the overthrow of Mohammad Mosaddegh in Iran on behalf of the British Petroleum Corporation (abbr. BP), the overthrow of Jacobo Arbenz Guzman in Guatemala on June 27, 1954, on behalf of United Fruit, and especially after 1973, we are witnesses that more often these are all the interests of various transnational corporations (abbreviated TNCs) and individuals from their ownership structure, named by some authors (including John Perkins) corporatocracy (John Perkins, *Confessions of an Economic Hit Man*, 2004;).

Since the founding of the United Nations (acronym OUN) in 1945, more than 80 states, previously colonized on the model of physical occupation or somewhat later imperialism, only formally gained liberation from physical colonial restraints and joined the OUN. This organization is, citing “Beliefs and fundamental human rights, to the dignity and values of human life, equality of men and women and equality of large and small nations,” at its session of the General Assembly held on December 14, 1960, adopted Resolution 1514 (XV), which, respecting the principles of equality of all peoples on the common planet, “promotes human progress and improves living conditions in greater freedom “.²

With United Nations Resolution, 1654 (XVI), of 27 November 1961, the OUN formed a Special Committee for Decolonization, also known as the Special Committee 24.³ At its seventeenth session, on December 17, 1962, the UN General Assembly adopted Resolution 1810 (XVII). By adopting it, based on the Report of the Special Committee, its membership was expanded by 8 new members. In addition, the Assembly proposed to the Committee to “Continue looking for the most appropriate ways and possibilities for the rapid and complete implementation of the Declaration in all territories that have not achieved independence.” However, due to invisible but obviously very influential forces, the Committee’s work has been reduced to symbolism and mere administration. This is evidenced by the fact that the Committee on Special Political Issues and Decolonization (also

known as the Fourth UN Committee) deals with a wide range of issues, from the rights of Palestinian refugees, peacemaking operations, demining, space activities, social information, atomic radiation and The United Nation University. Or to put it in a shortened version, more and more legal-diplomatic forms, and less and less life essences, and forced distancing from the increasingly pronounced problem of colonialism, which used it in practice, evolved and continued to spread with impunity. True liberation from the shackles for the former colonies did not happen, unfortunately, it only got a new form. And not just for the former colonies of Africa, Asia or Latin America. Bearing in mind the evolution of colonialism, its development and transformation in the fourth quarter of the twentieth century, especially with the establishment of the unipolar world (the so-called Maltese order established after the *de facto* capitulation of the USSR, signed by Mikhail Gorbachev on waters of Malta), a new form and strategy of a new form of colonial system was realized in the newly conquered territories. By provoking and managing crises, hybrid wars, wars under someone else's flag, performing more than 70 so-called "Colored revolutions," "Arab Spring" and the like, whose victims became anarcho-liberal elite of inappropriate governments and political movements around the planet, the new generations of colonizers, in accordance with the existing world order, their ambitions and current international circumstances, have expanded their power.

Using the methodological and logical principle of "Occam's Razor"⁴ in the context of considering the evolution of colonialism, we present the following facts:

It is important to understand that the epoch of various forms of colonialism has lasted for more than three millennia and has not ended to this day. Whether it was a slave-owning, feudal or capitalist political system, by 1989, by our account, it had gone through three stages of development, which sometimes overlapped and complemented each other in some parts of the world, so that they may have been more difficult to understand, but never excluded. Therefore, according to the manner of exercising real power over the colonized peoples, territories, natural resources and their states, we can briefly and essentially divide them into:

Phase I: Classical colonialism is most often realized through the armed forces of the metropolis, with the aim of physically taking economic benefits from the colony and direct rule over a certain territory and population. This is done by

the citizens of the metropolis and the voluntary parts of the colonized, with both categories of persons being culturally different from the other inhabitants of the colony. They are proud of that difference and do not want to accept any change in economic, political and cultural terms. Exploitation is ensured through physical occupation, deprivation of independent legal and economic status. The targets of colonialism are free or cheap raw materials and human labor, with the colonizer securing a market for his products, normally without any restrictions, thus making unjustifiably and many times more than in the metropolis. Instead of decolonization and liberation of the disenfranchised, this type of colonialism evolved in the twentieth century into a modernist and more complex form, imperialism.

Phase II: Imperialism, or neocolonialism, was created by industrialized nations, with the basic goal of building transcontinental empires and ensuring their survival and development in an international system which is built at the behest of the political West. In the first phase of development, the metropolis controlled one or several colonies, but since capitalism has a built-in natural need to expand, without which it cannot survive, the appetites of the colonizers increased. As there was no serious punishment for the crimes committed in the first stage of colonialism and consequently the confiscation of property, the next stage of its development was designed and carried out. In addition to increasing the number of colonized states and peoples, it was necessary to reduce the amount of financial investments (direct and indirect) in the new colonial system and increase own revenues. Imperialism is an economically dependent relationship between the metropolis and the colony, and in order to avoid the criminal, political and moral responsibility of the colonizers and those who serve them, it was emphasized that the metropolis recognizes the colony's political independence, but only formally. Essentially, things remained unchanged. That is, there was no physical occupation, visible to everyone and very expensive to maintain, but an independent legal status was granted to the colony, which normally cannot be mentioned without economic independence. It was about promoting, enforcing and carefully nurturing the theory of limited sovereignty. Essentially, it is about continuing a mean exploitative and parasitic relationship, in marketing terms, under a different brand.

Phase III: Technological colonialism flourished in the second half of the twentieth century, due to rapid development of science, and the aspirations of technologically and industrially developed countries to preserve and increase their scientific and technological advantage over the rest of the world, especially over countries

with rapid development. The basic tendency in the evolution of colonialism has been preserved and is reflected in the increase in the number of colonies and the improvement of the conquest and exploitative relationship, with the already known goal -increasing profits at all costs. If we compare with the first phase of colonialism, in the third phase there is no formal occupation and the colonies are publicly recognized with an independent legal and economic status. Also, there are no visible rough relationships, no visible chains and shackles, open killing, oppression and exploitation. But only formally. In essence, behind the scenes, everything is the opposite of what has been publicly declared, that is, unchanged since the establishment of the first phase of the development of the colonial relationship. An integral part of this type of colonialism is the so-called “brain drain”, young and talented children, intellectually the strongest part of society, potential carriers of the anti-colonial battle, from technologically less developed countries to more technologically developed ones.

**THE EVOLUTION OF COLONIALISM - PHASE IV:
FINANCIAL COLONIALISM AND A CURSORY GLANCE
AT THE INCONVENIENT TRUTH FOR THE COLONIZED**

“Within a social relationship, power means any chance (no matter whereon this chance is based) to carry through one’s own will.”

(Max Weber, “Economy and Society”, 1976)

Although they predicted that it would become extinct during the second part of the 20th century, colonialism, which took shape in the 19th century, intensified in the first half of the next century, at the beginning of the 21st century it returned in an amended edition, but with identical goals. All kinds of violent looting of goods and talented people from colonized nations. The old form of colonialism was expensive, clumsy, somehow too public and cruelly obvious for further use. It was necessary to devise a more cunning, cheaper and covert variant of the exploitative relationship, in which on the one hand the masters of colonization would keep for themselves, and it is desirable to increase, all the benefits of the colonizing system, and on the other hand avoid any guilt (criminal, political and moral).) for negative ongoing in the colonies. A variant in which the colonizer, the one who caused someone else’s misfortune and misery in order to get rich on it, will not be too publicly exposed. It was necessary to devise such a system in which everything

would be formally in accordance with the “democratic principles” publicly proclaimed in the West, and those principles would work actively and exclusively in favor of the colonizers. Something in the form of a genetically modified vassal relationship, supplemented by electoral engineering and simple, but still efficient, pirate or, in a new term, tycoon robbery. Technically, it is much easier to rob several hundred tycoons than several million or tens of millions of people. After all, the tycoons ruthlessly plundered their people and destroyed their state, which is why it is not a sin to rob them from the angle of colonization. These are the starting points on which the financial colonial system was built. Instead of the colonizer’s army, which is latently threatened from the metropolis, there are also armed police forces of the colonized people, which the colonizer does not pay, but through pseudo-elites⁵ imposed by force on the people, they are always at its service. Instead of a cumbersome colonial apparatus, there are colonizer’s diplomats who, according to the plan formulated in the metropolis, direct and control the exploitative, political and economic processes in the new colonies. Every day, through public appearances, they interfere in all the events in the colony, obviously imitating their ideals, proconsuls during the Roman Empire. Protected by diplomatic immunity and accountable only to their employer. Adhering to the basic principle that real power is always a secret power, in the newly conquered colonies they promoted a newly composed and self-subordinated pseudo-elite, through which they focused on indirect management in their “new possessions.” The behavior of the American and British ambassadors in the observed countries also shows that this assessment is correct. Regardless of whether it is Kyle Scott, Philip Cosnet, Peter Grenel (US Ambassador in FR Germany), Denis Keefe (until January 14, 2019, British Ambassador in the Republic of Serbia), George Mosbacher (US Ambassador in the Republic of Poland) , Mary Jovanovich (US Ambassador in the Republic of Ukraine who sent unusually harsh public criticism to the Ukrainian Government, calling on it to remove Nazar Kholodnitsky, the anti-corruption prosecutor. Details - Politika, dated March 7, 2019, No. 37828, p. 1). 2) and others, the colonial note in the monologue formally addressed to pseudo-elites and colonized citizens in the newly conquered territories is always present. Scott and Cosnet are the authors of the text “2019. should be the year of the agreement “, published in Belgrade’s” Politika “on February 8, 2019 and the Pristina newspaper “Zeri “, in which Serbia’s vassal relationship with the United States is covertly sought, financial colonization

and occupation of part of Serbia's state territory are neglected and *vice versa* valid diplomatic customs flagrantly interfere in the internal organization of the Republic of Serbia. It should be noted that the Article 147. of so-called the Constitution of Kosovo unequivocally states that the supreme authority in this occupied southern part of Serbia is the international representative. Article 153. of the same pamphlet contradicts the above and states that the final decision (ie sovereignty) is left to the commander of foreign troops in the southern Serbian province.⁶ At the time of the completion of this work, he is the commander of NATO forces, but it should be understood that, on the one hand, this is an attempt to legitimize the colonial attitude towards a part of our country, which is impossible. On the other hand, it is obvious that some transnational companies (TNCs) and promoters of their financial interests are tendentiously preparing the ground to introduce private military and police companies to our territory at the appropriate time of the foreign policy game, in order to continue the colonial plunder, and to hand over power in the occupied territory to a natural person who commands such a private armed group. Whether they are from the United States, the United Kingdom, France, Turkey or some other country, their goal is the same. It is obvious that for this reason it is emphasized - the commander of foreign troops, not the commander of NATO or the UN force. Such behavior is nothing, but the implementation of colonialism in its first stage of development.

The situation under Trump's administration is no better than in the State Department or in the White House. His former national security adviser John Bolton (previously known to the public for his support of the international terrorist organization Mujahideen-e-Hulk, MEK, MCO) in November 2018 called for the overthrow of the government in sovereign states, Venezuela, Nicaragua and Cuba. He repeated this attitude on Thursday, February 21, 2019, on his "Twitter" account, adding cit. "Ortega's (Daniel Ortega, legitimate president of Nicaragua) days are numbered and the people of Nicaragua will soon be free." (Bolton on Nicaragua: Ortega's days are numbered", "Politika", 2019, p. 2) And in all of the above, unfortunately, there is nothing new and for now there is no end of it in sight.

The West's strategy in North Africa and the Middle East is aimed at re-establishing a redesigned colonial relationship by provoking and managing crises such as the "Colored Revolutions" or the "Arab Spring", at the beginning of the process,

and then in first phase through pro-Western pseudo-elites in the colonies, they indebted those states beyond measure and worked to strengthen the newly established financial colonial relationship. Encouraging in various ways extreme nationalism, religious exclusivity, the extreme right of neo-Nazi and neo-fascist organizations, with the wholehearted help of organized criminal groups, whose number is almost industrially increased with the help of the capitalist model of earning money at all costs, and through separatism and territorial fragmentation of existing states, financial colonizers consistently pursue personal long-term plans for further territorial and economic fragmentation of the colonies, so that in the final version and in accordance with the plans of the colonizers, they are so minor that none of them can oppose a mediocre transnational company and its private army (meaning private military companies, abbreviated PMC. For example, Erik Prince, the owner of Blackwater Security Consulting, BSC, since 2006 has a battalion-sized operational group, with an offensive component of aviation and heavy equipment, which can be used anywhere on the planet. In the period 2005-2007, they took part in 195 armed conflicts in Iraq, in 84% of which they opened fire first. From 2009, they changed their name to He Services LLC, and from the following 2010, they used the name Academy. Prince founded his company after the American company DynCorp, founded in 1946, and the British Watchguard International, founded in 1967, and the British company Group 4 Securior, which employs about 550,000 people, meaning almost 4 times more than the East India Company at its peak of the power! .

By implementing anarcho-liberal ideas in economics and finance, we have got neo-racism in action, in which most financially colonized peoples are being kept in a subhuman state (a term borrowed from Karl Marx), so the Declaration of Human Rights or other legal documents from this area do not apply to them. That is why it is not surprising that with the introduction of new Criminal Codes in all financial colonies, each of the suspects had to prove their innocence, instead of the other way around, to be considered innocent until the state authorities prove his guilt and the court finds him guilty. By flattering the colonizer, the pseudo-elite created such a so-called legal framework in which the only thing that matters is how much money the suspects have, because those who are involved in the judicial process are engaged in racketeering. If he stole enough money from the state and fellow citizens, the suspect can bribe individuals in the police, prosecutor's office, and rest assured, he will have a benevolent treatment among judges, that is, he will be released or sentenced to a trivial punishment. During their stay in

prison, criminals of all profiles have more rights than normal inhabitants of the colony, which is why they quite justifiably feel privileged in the established colonial environment. While in prison, they rest, exercise, communicate with relatives, receive medical treatment free of charge and across the line (artificial shortages are created in the colonies to racketeer citizens, including the lack of timely health care, which is why they sometimes wait for months - author's note), improve and plan new crimes after release from prison. So, with the introduction of the colonial administration, the prison is no longer an institution for punishing those who have strayed, but a place for respite, recruitment and training. In this way, organized criminal groups become the left hand of the colonial administration, while the status of the right hand previously belongs to international terrorist groups. It is a projected social environment that is necessary for the colonizer to spread legal and general inequality among the population. The colonizer enabled careful cultivation, that is, almost mass, so to speak, industrial production of organized criminal groups, because he easily finds a common language with them in the plunder of the colonized people and what is left from national wealth and the state.

Unfortunately, in order to distract important things, in the colonies, the protégés of various domestic animal associations have more rights than the colonized people, whose leaders are usually financially, media and politically connected with the diplomatic representatives of Western embassies in the colonies. Through the prism of his ultraconservatism, the colonizer strives to keep the colonized in a mentally (but also technologically, media, financially and socially) subjugated state that he imposed on them by force, and even if it is possible to take them back as far back on the evolutionary ladder. He is absolutely aware that without such a state of colonization, there is no survival of the plundering system and there is no him (colonizer) and his chromatic privileges, nor astronomical and illegal profit. On the other hand, he needs neo-racism in order to preserve the rights he believes he has, the alleged rights that "naturally belong" to it him an exploiter and parasite, due to his alleged high place in the "food chain". From his (allegedly) high point of view of this process, the colonized does not deserve a different attitude, because he is allegedly less developed, not educated, did not try or could not defend himself in a conflict that was not even revealed to him. And that is why the masters of financial colonialism needed the media satanization of Serbia in the 1990s and other countries, Greece, Syria, Venezuela, Iraq, Iran, Ukraine and many others. In the case of Serbia, it was the psychological preparation of the terrain for financial colonization in which this free people are pushed into the mud, so that

the colonizer first looks bigger, more beautiful, more powerful and more significant to himself, and then to his satraps abroad and traitors in Serbia. In Serbia, a kind of practical exercise was carried out for the application of the principle of “colored revolutions” in all subsequent coups against legally elected governments. Over 70 of them. The insecurity that these conquerors carry deep inside, due to the injustice inflicted on the colonized, makes them hate even more strongly and persecute the oppressed peoples even more. Unlike previous epochs and centuries, it will not bring them anything good, because in the time to come, everything, absolutely everything, turns against them. And the macroeconomic situation, and technological progress, and the use of the Internet, and events on the ground, the disappearance of all great religions and much, much more. Screenwriters of the implementation of negative events on a planetary level see this and can no longer change anything radically in their favor.

The technology of “colored revolutions” in the colonized states gave birth to a special social category within the new phase of colonialism, which can be conditionally called a westernized pseudo-elite. It is there to provide an acceptable social envelope for the new / old product (colonization), the illusion of democracy and the rule of law, the illusion of a state which survives without sovereignty and its own army, but also some other illusions. Holding “free elections” at the behest of the colonizers, forming governments at the request of the masters of colonization would not be possible without them. Violent political engineering has created a pseudo-elite that should only resemble the Western elite in its appearance, that is, the colonizers. Drawing a historical parallel, their place in the social hierarchy would be very similar to the notion of “recently assimilated inhabitants of the colonies”, of Albert Memmi⁷. He described them as follows in the 1960s, quoting: “Recently assimilated inhabitants of the colonies are generally significantly different from the average colonizer. As if they want to compete with them in who is the bigger and better colonizer; they openly and arrogantly despise the colonized and persistently emphasize their borrowed “noble” status, often refuting it with simple cruelty and their own greed. They are still surprised by their privileges, so they enjoy them, defending them with concern and resentment. And when colonization finds itself in a bind, they provide it with the most ardent defenders, strike troops, and sometimes provocateurs. “(Albert Memmi “The Colonizer and the Colonized”, p. 44.) In addition to the realization of all other goals of colonization,

by creating a political pseudo-elite, the colonizer tries to provide himself with responsibility for the events in the colony to ensure ethical, legal and political inviolability. The criteria for its creation have been carefully designed and precisely implemented in practice through the application of behavioral principles. There could not have been, nor were there, personnel failures, so there are simply no honest intellectuals, hard workers or house peasants among them. Human specimens suffering from humanity, parts and patriotism were not shortlisted, only those who were vaccinated against these “diseases”. The political pseudo-elite was artificially produced by a heterogeneous group of mediocrities in order to facilitate the rule of financial neo-colonies and colonized peoples. It is there to sense what the unspoken wishes of the colonizers are and to fulfill them unconditionally and joyfully. Set to answer for everything that the colonizer does or refuses to do, the political pseudo-elite is aware that only with his multidisciplinary (media, political, military, diplomatic, economic, etc.) help it can be above its people, who were brought to subhuman condition (a term borrowed from Karl Marx). We have no doubt that by forcibly keeping people in a subhuman state, in an environment that the colonizers, from a safe distance, define as “controlled chaos”, and which is essential for the colonized uncontrollable earthly social hell, the creators of this relationship want to produce subhuman beings and let us remember, according to the Jain philosophy, they are the inhabitants of hell. (Note - Jainism or Jain Dharma, a classical religion that has its roots in ancient India, with still strong influences on the moral understandings and economy of modern India). And not only that. According to the instructions obtained from the metropolis, the inhabitants of the neo-colonies are allowed uncontrolled consumption of various types of drugs, from antidepressants to much more serious therapies aimed at changing the patient’s mental state. The obtained results are carefully recorded, sent and analyzed in the metropolis. The goals of such an intelligence-subversive action are to declare a significant population insane, mentally ill, and the colonies dependent, security risky and economically shaky. On the one hand, therefore, the necessary management presence of the colonizers is again insisted on, and on the other hand, public opinion is being prepared in the metropolis, that if private military companies (abbr. PMC) commit a crime or even mass murder, in order to preserve the colonial system, the metropolis, through the media (or the Internet), attributes everything to the mentally unbalanced inhabitants of the colony, which should have been eliminated because they could endanger the population, that is the alleged security of the metropolis. Among other things (vaccines, chipping,

etc.) and the state of mental health is discussed at meetings such as the World Economic Forum (WEF, an international foundation, founded in 1971, chaired by Klaus Schwab) in Davos.

Such degradation of innocent human beings, their declaration in the form of subhuman beings or even mentally ill persons, is necessary for the colonizer to threaten with the implementation of the next stage of his hell plan, which is called the threat of class depopulation of the planet or in other words, the depopulation of the lower social strata.

Like every colonizer throughout history, these masters of financial neocolonial relations are usurpers in all spheres. Regardless of whether they exercise their privileges directly or through planted local national pseudo-elites. In the eyes of the colonizer, even the most capable and richest among the westernized pseudo-elite will never be able to be anything other than one of the colonized and will therefore always be deprived of certain rights, which the colonizer jealously retains for himself. On the other hand, the self-deception of the pseudo-elite is directly related to their economic privileges in the colonies donated by the colonizers, its often ill vanity and, unfortunately, it can last for a long time. Uncritical acceptance by the political pseudo-elite of western culture, religious and social customs and languages of the West further alienates the opposing actors of the colonization process, colonized people and the pseudo-elite. With this attitude, the pseudo-elites remain a westernized part of the colonized society and are even more despised by both the colonizers and the remaining, but numerically majority and, more importantly, healthy part of the colonized people. On the other hand, through the low-quality media entertainment promoted by the pseudo-elite at the behest of the West, it is consciously subverting the people, in Serbia known as “pink culture”(in Serbia, this means more TV channels with pro-western, ultra-light and seemingly entertaining, but essentially dull and vulgar topics), and strictly controlled digital, print and electronic media, euryalism (a term derived from the name Euryale, an immortal symbol of sexual eccentricity, one of the three Gorgons, the daughter of the sea god Phorcys and Ceto, the sister of the dragon Ladon and the nymph Thoosa) and sthenism, (a term derived from the name Stheno, an immortal symbol of social extravagance, one of the three Gorgons, daughter of Phorcys and Ceto, sister of the dragon Ladon and the nymph Thoosa)through which all colonized peoples are forcibly pushed into mental and psychological simplification, primitivism, simplification of thinking, understanding and limitation of perception and

thus language, with the clear aim of forcibly impoverishing the national spirit. This realizes the old anarcho-liberal geostrategic project of raising global Sodom and Gomorrah (mythical cities of earthly sin and all forms of vice, which disappeared from the face of the Earth after the appearance of two angels around 1800 BC) whose inhabitants can be very easily managed and which, in the end, when the conditions are met and all energy supplies are exhausted, will not be difficult, truth to will or great sin, to thoroughly destroy such earthly chaos. It is an indisputable fact that the poorer the human spirit, the poorer the thoughts, and then the language for their expression is simpler, narrower, raw. Although the whole exposed process can be observed the other way around, from language to spirit. Thus, the entire colonized society on the axis of harmonization⁸ is forcibly pushed from the current minus eighth to minus tenth degree of this axis, that is, towards true hell, the cessation of any form of human and human life.

In 2010, the United Kingdom Armed Forces, together with the French Armed Forces, created the Combined Joint Expeditionary Forces (CJEF), and in 2014, the UK Joint Expeditionary Force (JEF) was created. When asked what the purpose of these forces (CJEF) was, the answer came very quickly with their use in Libya in 2011 and the destruction of a sovereign, internationally recognized state, which was attacked in the worst colonial manner without declaring war, which was carried out in the worst colonial manner without declaring war, which, we have noticed, has become almost common practice after certain international financial institutions and TNCs in 1972 took over from the West to create and implement foreign policy on a global scale. form of “early entry force ...”, but not announced where, is not a political trip into the unknown. The authors have no illusions that this is unfortunately essentially a continuation of the evolution of financial colonialism, which wants to use state resources in addition to private military companies (PMC) at least to a minimal extent, in order to preserve the illusion of general interests of Western countries. in the conquest and forced retention of new colonies. Combining the strategy of NATO and the USA to provoke all forms of crises in the world, this military structure has a self-proclaimed goal cit. “Crisis management, including early entry into enemy territory” (underlined by the authors). For all those who did not understand the clear message sent by the insatiable modern colonizers, we repeat, all those who are not able to defend themselves with weapons are potential enemies, that is, their potential victims. When it comes to JEF, it is very interesting that out of the 8 European countries that joined it on the British initiative, Finland and Sweden, although being convinced for many years to join NATO, immediately joined these forces. In addition to those cited in this cit. “the expeditionary force, which meets as needed ...” also includes the armed forces of Lithuania, Latvia, Estonia, the Netherlands, Denmark and Norway. No less interesting is the European Intervention Initiative (EI2), a military project launched by French President Macron in 2017, which brings together 14 European countries. Drawing perhaps for some an unpleasant historical parallel with the events of 1939-1945, for a complete list of a joint criminal enterprise known to the general public as the “Drang nach Osten” (war of conquest provoked without declaration, aimed at colonizing Slavic lands in the East, plundering and exterminating the indigenous population), this list lacks Croatia, Austria, the Czech Republic, Slovakia and Bulgaria. It is obvious that the strategic message of Russian President Vladimir Putin from March 1, 2018, on the possession of ultra-modern weapons of mass destruction (WMD)⁹

and weapons of mass destruction (WMD) did not reach the designated addresses. On the other hand, we cannot rule out that perhaps the anarcho-liberal elites in Russia, absolutely drugged by the concept of their own exceptionalism and decades of parasitism (after all, as in other countries where they are in power) convinced the backstage players and their patrons in the West to fully control social processes, the state, including the president, that is, people loyal to him and to the common concept of rule.

A LOOK INTO THE FUTURE OF COLONIALISM - PHASE V: INFORMATION COLONIALISM AND THE REALIZATION OF ABSOLUTE POWER

“The more laws and order are made prominent, the more thieves and robbers there will be.” (Lao Tzu, around the 5th century BC)

Increasingly numerous and serious attacks on state-owned information systems, companies and individuals have placed information security at one of the most important places in the national security strategies of every modern state. The general presence of computers and information networks, from public administration, financial institutions, to science, health and education, speaks of their (alleged) importance for modern man and the modern society in which we live. The technological leap that may happen soon, will unfortunately contribute to the increasing dependence of the human species and our civilization on information systems. New types of materials, 3D printing, artificial intelligence, mass use of robots, nanotechnology, microsattellites and more, will irreversibly change our lives, opportunities and responsibilities. We do not know in which direction the events will move, but it is obvious that the West is in an unprecedented conceptual, moral, economic and political crisis. Its rule matrix no longer works. Neither in the motherland, nor in the colonies.

of the Russian Federation, the results of which may lead to the annulment of the nuclear response of the Russian Federation, aggression against the Russian Federation which in its scope calls into question only the existence of the Russian Federation as a state. With this, for the first time, the Russian Federation publicly states the retention of the right of preventive nuclear strike on an opponent who is preparing to attack it by WMD or numerous conventional forces. This gives the Russian Armed Forces a new argument in the defense of their country, preventive restraint through the threat of inflicting the first blow in these or those circumstances. Note that all of the above technologically advanced weapons complexes only make sense in the event of a pre-emptive strike on a potential adversary.

Most or almost the entire field of finance is already covered by networks of information systems, and that is one of the greatest existential dangers facing our species. According to available data, the planet's gross annual product is about 70 trillion USD, and at the same time all banking instruments amount to 1200 trillion USD. Which means that there is almost 18 times more virtual money, the coverage of which is more than doubtful than the one that has real coverage, let's say in gold or industrial production. And we don't talk just about that. Can you guess just for a moment what the risk is, if someone, who has technological resources, carries out a mass attack on the information networks of all or a significant part of the leading financial institutions and thus wipes out the entire monetary system or most of it. Due to that, the People's Republic of China banned the so-called mining cryptocurrencies, trading them, even on foreign stock exchanges. The result on the stock exchanges at that time was lightning fast, lowering the value of all cryptocurrencies.

A special type of endangering the existence of ordinary people is the challenge that we all completely and exclusively switch to the electronic payment method. From receiving our salaries, pensions, to paying bills, loans and everything else. Such a virtual system for the world economy and a huge percentage of individuals on the planet would be virulent very quickly. This means that a very small group of people could influence the real world through the digital, imaginary world, without any authorization or punishment for what they have done. By one click on a computer, a person, hundreds of millions of people or groups of states that are disobedient to the "elite" could deny access to his/their financial resources. Without them, there is no food, no treatment, no education, public transport, purchase of fuel, or anything that is necessary for the survival and development of our species. Although they are not on the public stage, they have never participated in politics, announced their plans, nor been elected and given political power, in this way this small group of people hidden behind the screen of power, could realize the dream of all tyrants from the former epoch. To have absolute power and, like alchemists, turn the unreal, the virtual, into reality and vice versa. It sounds almost like the power of superhuman beings, right? They obviously act from the position of their superiority, and does that mean that most or almost all of us, the inhabitants of the planet, consciously accept that based on their activity, we are a subhuman species, biorobots, hybrids, automats or mentally ill people destined for extinction? It is important to understand that with their free will, they could be able to destroy hundreds of millions of people, states and economic systems, and

to get even richer on that. Without any punishment, for now. The basic question for all of us who make up the vast majority on this planet is, should anyone ever be allowed to do such a thing?

One small example from practice. Only in illegitimate operations with shares, in which the ownership shares of companies are fictitiously transferred to the bank, in order to benefit the domestic investor, the German state has lost about one billion euros a year (1.2 billion dollars) due to such operations from the gray zone since 2011, said “France Press” agency in 2015. Ordinary citizens will have to make up for the loss made in that way, by paying their tax obligations properly.

Observing the evolution of colonialism, we notice that its fifth phase fulfills the necessary characteristics to be called global and total. And that is one of the goals set before the Anglo-Saxon special services when the cryptocurrency project was conceived. Except for a few sovereign states on the planet, all others are in one way or another encompassed by this phase of colonialism. Information technologies and networks, the Internet, social networks, digital media, cryptocurrencies, are all different manifestations of the fifth phase of colonialism and digital, electronic or numerical colonial relations. And is a way to try to realize the absolute power of a certain group of people. Whether it is good and what consequences can already be glimpsed, judge and conclude for yourself.

CATEGORIZATION OF MODERN COLONIES

In addition to evolution, modern colonialism is also characterized by its diversity in application and the consequences it leaves behind. During the 20th and at the beginning of the 21st century, modern colonies could in principle be classified into 6 basic levels:

- type *de luxe*, it includes only Switzerland and its economic system, which in the last 100 years has profited the most from the world wars, the First, Second and Cold War. It is the finest distillate of financial colonialism, which is carried out with steel discipline in sterile conditions, in the evening dress and with white gloves. Switzerland is a place where so far no financial terrorist or mass murderer has been asked about the origin of money or other deposited treasure, because the question is “banking secrecy”. Supposedly an idyllic alpine confederation, a kind of shop window-bait for all the naive (people, state administrations and their

politicians) on the planet. With an open subtext, “if you are as obedient as possible, you can be like Switzerland.” There is no foreign military force on its territory, but its inhabitants are disciplined, well-trained and they maximally serve the interests of colonialists of all colors, because they have significant material benefits and privileges, so they feel their interests as their own.

- type I, Japan, Germany, Italy, South Korea and similar countries. The basic characteristics of this type are that both the colonizer and the administration in the colony, through the media, try to maintain the semblance of the colony’s sovereignty, its, let’s say, independence or its own financial policy. Although these are economically and technologically developed countries, there can be no question of their sovereignty. The main reasons are the subordination of the Central Bank and financial institutions to the interests of external factors, primarily international financial institutions, and a certain number of occupying soldiers, which the colony with the existing administration neither wants nor can suppress from its territory.

- type II, Czech Republic, Slovakia, Poland, Slovenia and similar countries. These are states that are subject to colonizers at two different levels. Directly from large colonizers from trans-national companies (TNCs), international financial institutions, on the one hand and colonial forces from the immediate environment, the so-called “Centers of gravity” (American, German, Francophone, Turkish, Italian, etc.), on the other. The semblance of independence is significantly weaker than the previous category, but the media is trying to maintain it. On the political level, the local pseudo-elite is publicly praying for the presence of the colonizer’s military, media and political force on the basis of imaginary security challenges through the mass media. It is important to understand the basic principle - as pressures from outside and directed processes from within accumulate and grow, the level of sovereignty of the observed nation-state decreases.

- type III, in which the negative influences of TNCs, financial terrorists and centers of gravity are combined and multiplied, with all their malignant effects. Moving away from the center of gravity, we encounter the application of the modernized concept of “scorched country”. The farther the periphery is from the center, from the metropolis, the more shortcomings of quality state and public administration are pronounced. The concentration of industrial facilities is decreasing, the infrastructure is less developed, education is weaker, and living conditions are getting worse. As a rule, there is a financial stimulation of the colonizers to come and “work” in the colony, for which the pseudo-elite (appointed by them) pays them

amounts of 10,000 euros for one open job. It is important to add that such economic financial stimulation simply does not exist for the domicile, colonized population. In such countries, it has become normal that if the value of the domestic currency falls in relation to the so-called stable (western, colonizer's), prices in trade are rising, but in situations when it is the opposite (not often, but it happens), prices are not falling, and the pseudo-elite (anarcho-liberal administration) does not react. We would say that such countries include: Hungary, Romania, Serbia, Montenegro, Greece and many others.

- IV type, appear on the lines of contact of two or three zones of political-economic gravity. In such countries, a foreign military force is openly present, political, media, diplomatic and economic pressures are growing, and the pseudo-elite is openly proud of its vassal status. A large number of private military or police companies are engaged and there are frequent cases of armed conflicts under someone else's flag. If he feels the need for that, through certain mechanisms, the colonizer introduces international factors into the political game. First of all, because of the blurring of the political image, its abolition, stronger pressure on the domicile population, and normally, above all, because of the strengthening of profits. Countries of this kind include Libya, Bosnia and Herzegovina, Ukraine, Iraq, Macedonia and some others.

- Type V is reserved for the most difficult cases of colonialism (classical, technological, financial, etc.), which are intertwined, complementary and, what is especially interesting, they are almost not hidden. These are primarily countries in Africa, Asia and South and Central America. In them, at the expense of the financial interests of different types of colonizers and occupiers, everything is allowed, even crimes of the worst kind, for which the perpetrators, and planners have not been adequately sanctioned so far. Private military and police companies or special services of the metropolis are usually hired for such "jobs". Such states and their political system are almost never on the headlines of the Western media. They seem to have been forgotten and left at the mercy of the colonizer and his servants. When it comes to the living conditions of the colonized population, we can state that it is a kind of earthly hell created and carefully nurtured by all types of colonizers, with the voluntary cooperation of the local pseudo-elite.

INSTEAD OF A CONCLUSION

Always keep in mind that every human work is divided into two categories: production and management.¹⁰

You can engage in the most profitable activities, mining rare metals, information technology, grinding diamonds, securities, nanotechnologies or any other very profitable activity, if your community or your society is not well managed, and it is essentially less important whether it is a matter of bad intention or ignorance, there simply cannot be prosperity and well-being for you.

The authors claim that it is necessary to understand that we are in an ideological war, which has not been announced to us, but at different levels (military (hybrid and asymmetric armed conflicts), economic (sanctions, trade wars, etc.), financial (interest rate, printing money without cover, etc.), media, diplomatic, philosophical, etc.) has been leading intensively against us for decades. If we want to win in it, which we have no doubt about, we must first be aware of that fact. Viewed from both lines of conflicting sides, the use of military, genetic, economic or some other weapon can only solve a battle in that global class conflict, but it cannot solve its fate. It will be decided on the ideological battlefield. Planners of the colonization process in the West are very aware of this fact and have been intensively cultivating the illusion of the possible existence of a society without ideology for years with the help of mass media in the colonized countries. It is good to point out that this ideological concept is also an ideology, but without a winning capacity, which is certainly known to its creators and main promoters. With this, they want to further obscure the political situation and, more importantly, buy extra time for themselves. From this point of view, the point of view of the victims of the colonization process, we can and must lead a just ideological defense and we can win only if we publicly confront anarcho-liberal concept and its “values” with our positive value system, our conceptual power, our new ideology, new language, the meaning of human life and such a form of common future that we are ready to fight till the end.

The fact that a multi-layered conflict is being waged intensively against us must produce an adequate defensive reaction. We must declare the state of defense against it as soon as possible, report at least a partial (and at certain moments

complete) mobilization, introduce the so-called war functioning of the economy and finances, consolidate and echelon the defense, make plans for asymmetric responses in all areas, adequately fill units with manpower and technology and completely regroup all the forces of our society to win the unjust hybrid conflict, which was imposed on us without declaring war.

Although it changed its form, the war did not change, nor can it change its essence. Based on Clausewitz's claim that war is an extension of military policy, thinking about peace after the end of the Cold War (some authors consider it the Third World War, after which the Fourth World War began in 2008) and the establishment of the Maltese Order, we come to an undeniable conclusion. that the peace which we live in, is nothing but the continuation of a previously waged war (and / or wars) and the realization of these unjust goals, by other means, economic, financial, cultural, informational, digital, religious and political. And in all theaters (or spaces) of operations a) geocentric, b) cyber and cosmocentric and c) spiritual - conceptual. Let us remind ourselves that the geocentric theater of operations (TO) is limited by three borders: land, sea and time. Cyber and space theater of operations define the boundaries of: cyberspace (from the Earth's surface to the height at which geostationary satellites are located (approximately 36,000 km above the equator)), the Earth's electromagnetic field and the gravitational field of the Earth.¹¹

Spiritual-conceptual boundaries drawn from: minds, souls and hearts of people, surround the cultural-civilizational theater of operations. Within such a framework, a new or modified old type of colonization is being established, the basis of which is, among other things, the creation of "gray zones" (a term established in 2015 and linked to US Admiral Eric Olsen, former Special Forces Commander) in which everything is possible and for which the rules of international, traditional and land law do not apply. With the successful escalation of hybrid conflicts by

the aggressors of the “gray zone”, over time, they turn into the so-called “fallen states”, a favorite euphemism of the political West in our time. At the very beginning of performing war actions within the strategy of hybrid warfare, asymmetric armed conflicts or the doctrine of low-intensity conflicts including information wars and the so-called “Colored revolution”, it doesn’t matter, because the goal and the desired result are the same, we come to the essence of the activity, and it is, as always, reduced to new conquests, killing and using various forms of force to seize other people’s material and immaterial values. However, you should not be confused by the fact that in the “colored revolutions” there are not a large number of victims at the beginning. Due to the cumulative effect, there are several consequences, in the number of millions, foreseen by the plan in the final outcome of the event. From the destruction of industry, infrastructure, culture, poor health care, shortening life expectancy, catastrophic education, mass drug use, permanent migration of young, talented and educated, to the almost industrial production of organized criminal groups and everything negative that they bring with them. All of this has been carefully planned in certain centers in the West to preserve the anarcho-liberal capitalist system. That is, capitalism itself as a political system, on a global level, and at any cost, which, according to planners, as always, should be paid by others, meaning, those who are undeservedly thrown to the bottom of the social ladder. In the realization of the mentioned tasks, the system of false, virtual and virulent political priorities and goals is of priority importance, which are declaratively presented as real through the media and the Internet. The best example of such activities is the export of maritime law, Anglo-Saxon democracy and all the famous and fictitious moral norms related to them. The success of such actions is best illustrated by the state of international relations and the rule of (maritime) law in all old and newly conquered colonies.

Anarcho-liberal type of capitalism, like any other form of parasitic system called capitalism, deprived of the external ideological challenges it had in socialist society, could not, did not want to, nor had the internal capacity to change itself into a system that would be just for all citizens or at least most of the population living in it. At this moment, the only thing that the behind-the-scenes creators of events on the international scene are ready for is the previously known motto “that things should only be formally changed, so that the essence remains the same”. The absence of their desire for fundamental changes and the inability of privileged, so-called the elite sympathizes with the suffering of millions, and in some countries we can talk about tens or hundreds of millions of our fellow citizens, who do not

have the means to survive, and not to mention some planning and implementation of development, leads to a situation in society that can be interpreted and as pre-revolutionary. The justified anger and aggression of the disenfranchised will continue to grow, because there is no interclass understanding and improvement of their living conditions in sight. On the contrary, arrogance, ignorance and arrogance (of those who in just a few years became rich beyond the limits of their dreams and deposited everything looted at the colonizers or the so-called offshore zones under his control - the author's note), are present at every step, they encourage and will encourage a possible spiral of violence, which could be much worse than that of the 1960s and 1970s. It may be the worst in known history, because the means of destruction are technologically very advanced. If you look at the countries in which the so-called "colored revolutions", you will see that there are no longer functional units of industry, finance, defense, culture, education, health and social protection. A plan has been implemented to create a modern scorched country, whose territory and population are increasingly being pushed into a situation that could most easily be characterized by the term black hole. Let us recall the information from the theory of astronomy that black holes have such a strong gravitational field that no form of matter or radiation can be imprinted on them. The theory goes on to say that anybody that has mass, if exposed to adequate pressure and compressed into small dimensions, defined by the Schwarzschild radius, can become a black hole (slang for "garbage", responsible for collecting energy and matter in the eternal information field, which will at one point in time re-create a new universe, that is, a new life). According to one of the hypotheses, our planet Earth, if it was reduced to a sphere with a radius of 9 millimeters by using adequate pressure, would become a black hole. It is interesting that this kind of thinking can be applied to the attitude towards countries, their economies and national finances. If they are exposed to strong enough external pressure (which is usually combined with internal betrayal) on defense, financial, economic, cultural and industrial capacities, each of them can become an economic, social and civilizational black hole. We agree with the observations of some analysts, who assessed that the arrogant hegemony of the USA after the creation of the unipolar world (the so-called Maltese order, established after December 2/3, 1989), produced several geopolitical black holes on the common planet. Unless urgent measures are taken to stabilize human society - increase of employment, perhaps a guaranteed general income, but certainly redistribution of surplus value, return of funds illegally taken to "tax havens" in their countries of origin, much better quality of education and health care, changes in understanding moral principles and information, especially in one part of the ruling elite, the expansionist (aggressively parasitic) who wants everything for himself immediately, (all of the above could

be reduced to the harmonization of substance and function), we are afraid that we will very soon enter the era of extremely fierce class struggle which, given the existing efficiency of armaments, could end in potentially unpredictable consequences for our species.

All the circumstances manifested on the international scene from the end of the 20th and in the first two decades of the 21st century show on the one hand the meaninglessness, obsolescence and vagueness of the existing international law, because, especially since the end of the Second World War, the main culprits for crimes against general peace and progress are not sanctioned. On the other hand, we see the growing arrogance and insatiability of elites from financial circles and transnational corporations (TNCs), who, because of their accumulated assets, seem to think they are untouchable demigods and believe they can act contrary to all known human laws. Regardless of the example you choose, Syria, Iraq, Libya, Venezuela, Italy, France, Germany or Serbia, you will find identical patterns of behavior of aggressors / colonizers / parasites and very precisely chosen targets. Establishing a fierce colonial relationship, in which only at first glance no one is to blame for the ruthless plunder of natural, human and national resources. Not evolution, but the return of financial institutions and transnational corrosion (TNC) to the old solutions of the British East India Company (but also other Western companies with identical goals), is the formation of special police units, which, as in Bangladesh, should allow further parasitism and reckless economic exploitation of hundreds of millions of people, across the planet with a single goal - the criminal enrichment of a very small number of people. In this Asian country with 165 million inhabitants, TNCs have had their so-called "industrial police", whose task is to ensure at all costs the process of further exploitation of precariat, whose monthly salary is only 95 USD (more details - Vladimir Vukasovic, "Rebellion in the world weaving mill", "Politika", No. 37779, from January 16, 2019, p. 2). Legitimate demands of disenfranchised workers for higher wages are shamelessly brought by the representatives of employers under their imbecile demands for higher productivity, passing over the fact that the working day, in addition to the introduction of the so-called modern technologies (digitalization, informatization, robotization, etc.) increased from 8 to 10 or even 12 or more hours, and the value of wages continues to decrease drastically, which makes any conversation with liberal parasites and their servants completely meaningless. In Chapter 14 of his work, "Capital", "Primitive Capital Accumulation" (pp. 630-674), Karl Marx writes about the various criminal forms of the original accumulation of capital in Asia, Africa, and America. Mass robberies in Central America, slave trade and organized public drug trafficking planned and carried out through the East India

Company and pirate gangs in the Caribbean, brought Britain such a capital inflow at the time that only treasures looted in the Caribbean could repay the entire state debt. and they were left with 50% of the value of the looted treasure. Without a single penny invested, the non-humans of that time became rich beyond the limits of their dreams overnight. By exploiting, plundering and spreading drug addiction, they destroyed entire nations, which their clients and protectors looked upon favorably (sounds very recognizable, doesn't it?). From today's point of view, we cannot agree with Marx's assessment that the mass plunder of the Portuguese, Spanish or French, or those who plundered America, carried out in the Atlantic, was not part of capitalism. If he named the piracy of that time organized international terrorist or at least organized criminal activity with the aim of surviving part of the financial elite in power in the British state, but on the other hand even if he had given a correct assessment of the essence of the Western banking system, we are convinced he would not even experience an attempt to publish the first edition of "Capital". According to the current Western terminology, the modern assessment of such well-organized international terrorist activity, successfully carried out under someone else's (pirate) flag, certainly belongs to the domain of hybrid warfare, done under the protection of the number one naval power of that time and at the expense of economic interests of its elite. The only difference in relation to the current situation is that the then elite of the United Kingdom understood very well that around them and for the protection of their economic interests, they must have its numerous and materially well-situated peasantry as a nursery for persistent, tenacious and combat infantry (see Capital on p.636 - At that time, the inflows of finances from the colonies were distributed so that a large percentage of the metropolitan population felt the benefits of the colonies in various ways, which is no longer the case in the last 30 years, as part of the renegade elites from Finnish circles and TNCs keep everything to themselves.), and today's Western elite relies more on private military companies, information technology and artificial intelligence, than on their peasants or workers. We are of the opinion that such an attitude towards their immediate environment will unequivocally avenge them and contribute to their quick defeat.

This social system (capitalism), as in previous centuries, cannot survive without plunder, violence and aggressive territorial expansion. It is a part of its nature, a part of its being, the very essence of its existence, and without that characteristic there would be no capitalism as such. The French philosopher of great enlightenment, Baron Holbach, wrote a quote in the 18th century: "There is no more dangerous creature alive than a businessman seeking for his prey. The passion for getting rich in that being took the main place in the human soul, suffocating all

justice. Whole nations fall victim to greedy businessmen who deceive them with the hope of wealth, whose fruits they reap only for themselves. States are left without inhabitants, taxes are piling up, nations themselves are poisoned by greed for wealth, they fall into misery to satisfy the greed of a small group. “- end of quote (published by Ljubiša Vićanović, playwright, in the section” Views “, newspaper” Politika “, January 8, 2014)At the same time, these characteristics are the main reason why the alienated, expansionist part of the financial elites and parts of TNC managers, those who are prone to financial terrorist attacks, so easily find common ground with organized crime and international terrorists of all colors. They are united by a black passion for crimes, robberies, kidnappings and murders. It should be borne in mind that capitalism in the metropolis has always been fundamentally different from that in the colonies. In the metropolis, the rules of the social game were always more correct and consistently enforced, because it was necessary to preserve the legal and social order and thus ensure the inviolability of the entire elite. In the colonies, everything was the opposite. For the sake of robbery, personal enrichment of individuals from the metropolis and taking the robbed out of the colony, everything was and is allowed.

Karl Polanyi in his book “The Great Transformation” from 1944, dedicated to the class relations of the nineteenth century in England, perhaps formulates in the best way what capitalism is. According to him, it is: “a political system built to overcome the resistance of traditional society to the catastrophic consequences of technological revolutions.” In such a situation, it is clear that none of the creators of these social relations need humane and civilizational progress, true development of knowledge, culture and education. They do not need progressive knowledge and new technologies, especially not those aimed at mass access to free energy sources in unlimited quantities. They are perceived as the most important opponent of the existing financial and political elite in the West, and unfortunately not even a part of the East lags far behind them. According to some authors, without completely destroying such views of the world, our next evolutionary step cannot be realized.

The authors hope that the public debate on the essence of this paper will contribute to the understanding of the magnitude of the problem into which someone has thrown us by force and deception. We hope that the discussion will continue in the plane of immanent-ontological thinking (basic socio-system processes, management, cognition, training and production), but we are aware that certain interest groups that are still active on a global level, can abuse and deform this knowledge, as they did before with other types of knowledge, in order to transfer deformed thoughts to the transcendent-mythological plane (it consists of war, transcendence,

control and form)¹². Their main goal is to try to realize their interests, meaning, to continue spreading the planetary chaos exclusively, for the personal enrichment of the so-called elite. Why did we mention this part? For the simple reason that it is important to explain to readers that time and environment no longer work for the benefit of this group of people and those who have consciously chosen to serve them. The genetic mind of an increasing number of the inhabitants of the planet is unstoppably waking up and connecting, and tectonic social changes are on the horizon. No “knowledge operators” with the help of torsion fields, address modulators in chips, QR codes, 5G or similar technologies will help the creators of the current criminal order.

The entire science, with its comprehensive support of chrematistics (which is still publicly called economics, although it is not essentially so) and its technologies, continues to fragment rapidly and is irresistibly moving towards its disappearance. In doing so, it devastates its reputation and what little is left of its declarative goals. No one can change or stop this regularity anymore. We are of the opinion that science should not be particularly regretted, because since its inception in almost all situations, it has been directed against the true progress of our species. It was a powerful catalyst for pushing civilization into negativist programs. On the other hand, in that unnatural symbiosis, chrematistics has always supported only scientific directions of which it has a financial interest, and their goals, as a rule, and did not coincide with the desired development of humanity. As we can see from the history of the development of science so far, these have always been dead ends and misconceptions, after all, as well as the long-cherished illusion that only the application of technology can evolve. That is why we believe that Viktor Schauberger was very right when he said: “Technology is always a deception of the mind.”

For all those who think that the existing chrematistic and parasitic financial system has no alternative to its false, often virtual, but always virulent goals and priorities, let them at least try to imagine what the economy of any sovereign state would look like if it decided to be the National Bank exclusively, under its control. This automatically opens the possibility that all state salaries and pensions, instead of through commercial banks and liberal officials installed in them (who were elected according to the criterion of unconditional loyalty to the West), go through newly opened accounts in the central bank. Without any bank compensation or restric-

tions. This would make the main financial institution of such a state an extremely powerful financial weapon of the same sovereign state and its free citizens, which can give commercial loans to its companies, public institutions and citizens with an interest rate of 0%. Not only that. In this way, the entire anarcho-liberal banking parasitic system (regardless of whether it is a metropolis or a colony) is left without influence on the economic (keep in mind this time not chrematistic, but truly economic) flows of a given state. With absolutely strict control over the spending of financial resources, the national economy thus cannot go beyond the annual inflation of 1% and this is at this moment an undoubted way to increase the competitiveness of all branches of the national economy and very fast recovery of the entire economy. Do not have any illusions, the precondition of all preconditions is liberation from all kinds of parasites among us and around us, but also all forms of their colonial shackles that restrain us. Ideological, mental, spiritual, energy, financial and all the rest ...

It is important that in building our new vision of the future, we understand that nothing can return, it cannot be as before, because those times have passed and that is why we need to look for completely new solutions. At the moment, the old political systems are not working, the parties and their leaders do not have or will have a vision, charisma, nor their think tanks can produce something new, because they have already destroyed all forms of the future published in the West through futurecide. With them, everything came down and will come down to recycling what has already been seen and cosmetic changes (which could also be called glammingup corpses) in order to preserve the existing one, in order to preserve capitalism at all costs, but it is clear to the most stubborn among them that this is no longer possible. The religions that created capitalism do not provide an answer to the growing dilemmas of their believers, because infernal egregores no longer exist. All kinds of spiritual rites are also no longer in the desired function, and those who perform them do not tell the faithful, and their curiosity to explain to them what is happening with our world, which is why nothing works as before, usually shrug or keep silent about the truth. We have no dilemma that we are all rapidly approaching the point “where everything that was secret will become public, and the invisible world will become visible” (the sentence is borrowed from AP Devyatov).

In order to overcome the hopelessness of civilization into which we have been forced, we as a species urgently need to set a new look for the desired future. That is why at this moment it is primarily important to set our (by no means someone else's) sense of the new social organization, to choose its symbols, signs and colors. To create healthy and just goals of shaping a completely new conceptual power,

a new language, a new ideology and the values of a new society that should be raised together. It is an imperative without which there can be no way out of this primarily ideological impasse, there is no further development and this question is undoubtedly the survival of a huge number of people on the planet. First and foremost in this direction, it is necessary to devise a new political language to describe the desired version of our future, regardless of the potential concentration of esotericism in it and the affected horizon. We must find an adequate combination of words and new terms with which we can fully and, most importantly, extremely honestly characterize the variant of the future in which we want to live.

Mandatory in the short and long term and quite acceptable to the majority of the existing population (e.g. a) The USSR and SFRY did not “disintegrate”, as is often associated with them in the media, but by the actions of certain groups of non-humans they were broken, destroyed, b) the term “deep state” is invented, it does not exist, behind it are hidden international financial terrorists, who do not want to respect the prescribed social rules, etc.). Secondly, starting from the adopted linguistic terms of our collective future, we must devise and implement the ideological doctrine and conceptual model, necessary for the conquest of the desired form of society, with all their characteristics. This gives us a basis for creating a building with polygonal foundations and walls, which is strong, indestructible and which can last forever. In this way, we consciously and now emerge from the Imposed Matrix of Evil and actively move towards the formation of the General Matrix of Goodness, a healthy foundation of our survival, a common happy future and the beginning of a new cycle of true development.

Сажетак:

Интересантно је да се генерално о колонијализму његовим појавним облицима и последицама мало говори, а још мање пише. Стиче се утисак као да је тема превазиђена или је можда неко намерно гура под тепих. Овај рад је скроман покушај да се подаци систематизују у методолошку целину и разматрају на основу објективних последица које остављају. Свесни чињенице да је у питању огромна материја покушали смо да кроз сагледавање базичних принципа смањимо количину обрађиваног материјала, нормално и колико год је могуће не на уштрб квалитета рада. То је покушај да се кроз откривање кључних питања у овом процесу дође до суштине изучаване материје. У основи рада је феноменолошки модел еволуције колонијализма и распрострањавање финансијског колонијализма, као његове четврте развојне етапе, препознат и описан одређеном линијом размишљања. Следеће питање које се само по себи намеће је, дали постоји и наредна, пета етапа колонијализма и у чему се он огледа? Свакако то су криптовалуте и прикривене намере оних који су их осмислили, то је имагинарни свет финасија, виртуелан и вирулентан, способан да се у жељеном или можда некоме потребном, хиљадитом делу секунде уруши и учини сиромашним све оне који су наивно веровали у његову коректност, револуционарност и ефективност. Рад је скроман индивидуални покушај аутора да постављањем кључних питања и тражењем одговора на њих, односно да путем својеврсног мисаоног експеримента, пронађу смисао у оном где га само на летимични поглед раније није било превасходно из личне перспективе.
