RELIGIOUS SECURITY AS A PART OF THE INTEGRATED SYSTEM OF ANY NATIONAL SECURITY, WHETHER AND WHY ITS CREATIONS IS NECESSARY?

“Each thought ends with the shortening of specific muscles.”

Abstract

In the last 30 years, the whole world has been more or less exposed to the process of religious and ideological radicalization of human thought through various media, the indisputable goal of which is to bring individuals, groups and parts of the people to a state of extremist form of thinking and acting in that direction. As a rule, it is used to polarize attitudes within a certain nation or state, but very often also to create an ideological base for carrying out various terrorist attacks, the number of which

is growing uncontrollably in the world. The creation of various interest groups in the post-capitalist system indicates the inability of liberalism to provide social security. The absence of understanding between different confessions and peoples is unequivocally emerging as a special problem, and in the last few years, even within the major confessions, disagreements have been growing on numerous and vitally important issues. Clashes of views, incendiary rhetoric in the media that is becoming increasingly harsh and obvious conflicts of interest of leadership groups within faiths and between major denominations may lead to open conflicts with unpredictable consequences, this time on a global level. There is a very strong impression that nothing is being done to initiate the process of better mutual understanding and to reduce existing tensions to a level from which it is possible to conduct reasonable dialogue and, what is also important, peaceful coexistence.

Keywords: security, religion, national security, terrorism.

INTRODUCTION

Hypothesis of the paper: Is individual, group, national and supranational religious security necessary for the conditions of a harmonious international order, whose appearance suggests pre-chaos? A topic for reflection and debate in the professional environment.

The paper is fully devoted to the innocent victims of the terrorist attack on “Crocus City Hall” in Moscow on March 22, 2024, but also to all other numerous innocent victims of international theoretical groups. May their path to Eternity be blessed and may their murderers, the organizers of crimes and the orderers of all misdeeds on the planet receive the well-deserved punishment!

Basic terms - security, social, national and state, religious security, supranational religious security, terrorist attack, global ideological division, conception, ideology, New culture.

In the general theory of security, the following terms are used:

Danger is the presence and action of forces and factors that are essentially destructive and destabilizing in relation to a certain system, which are capable of causing damage to that system, temporarily or permanently putting it out of operation or destroying it completely.

Stability is a dynamic state that, when external or internal actions change, allows the system to preserve its basic qualitative and quantitative parameters in predetermined values.

Damage is a negative change in the value of the subject, i.e. a change that negatively affects vital characteristics and is therefore undesirable.

Risk is the ratio of the probability and consequences of an unfortunate event.

Protection is the provision of means to support the necessary level and quality of vitally important assets or entities from reducing benefits or increasing damage.

The concept of general security, national security and other forms of the same

The very concept of security as a mental construct implies a state of protection of the vital interests of individuals, society, legal, religious and state subjects from external or internal threats. Modern society has developed a whole spectrum of different types of security, from aviation, social control system security, biological, military, state, ecological, economic, energy, industrial, informational, national, nuclear, fire, radiation, technosphere¹, digital and others.

Social security is the ability of social institutes of society to ensure independent, self-sustaining and stable development and realization of the chosen

path of society. It is primarily determined by the level and state of social relations.

According to Western bibliography, the term “national security” was first used by American President Theodore Roosevelt in 1904, in his address to the US Congress. National security, as we understand it today, formally appeared in modern political science after the Second World War in 1947 with the adoption of the National Security Act in the USA. First of all, it is the state of protection of the nation from external and internal threats, and in fundamental science it is studied in a multidisciplinary way through the theory of national security. In the realization of its tasks, objects and subjects of study, national security is connected with other sciences: sociology, psychology, political science, systemology, theory of international relations, philosophy, conflictology, legal, economic, military and other sciences. In its work, it uses different methods: empirical (experiment, observation, examination, research, etc.), theoretical (synthesis, analysis, abstraction, comparison, generalization, formalization, thought experiment, etc.) and heuristic method² of individual and collective character, for solving prognostic and constructive tasks, searching for new approaches, ideas and solutions. Its methodological base is basically made up of: general theory of management, system theory and conflictology.

State security is a system of guarantees of the state apparatus aimed at protecting the sovereignty, territorial integrity and independence of the state, basic values in society, spiritual and material resources, life skills, civil rights and freedoms of Man.

The methods of ensuring each security are:

- creating an adequate system and means for protection against endangerment,
- management of known risks,

- increasing the protected person's resistance to negative effects (strengthening of immunity) and
- isolation or elimination of security threats

State and current challenges in modern society

The basic difference between religiosity and superstition, i.e. the basic manipulation of pseudo-religious reading in the process of radicalization, primarily of young people, in order to bring them to a state of extremism and violence towards all other people who have different life attitudes than themselves, is found in the tendency of individuals and groups who they form under different influences (external or internal) towards cultivating negativist attitudes (mental, religious, cultural, social) and the cult of violence. Apart from theology (divinity), the scientific disciplines of sociology of religion, conflictology, religious studies (comparative religion or history of religion), philosophy of religion, etc. are also interested in religion. It is indisputable that all efforts for mutual understanding are useful, but the fact is that despite the increasingly strong efforts of certain groups towards globalization, the increasing and extensive flow of information, as a species in the last two hundred years we have made extremely little progress on the path of mutual understanding, appreciation and global prevention of violence. It is very often based on a certain sectarian thinking or tendency towards violence, allegedly based on a religious basis. At the same time, keep in mind the fact that the first text known to us on the subject of understanding the history of religion and their comparison was the "Book of Religions and Religious-Philosophical Teachings" (Shahrastani), written by Muhammad al-Shahrastani in 1127.

Sociology of religion as a part of sociology studies mutual relations between religion and the society in which it operates. Unlike the philosophy of religion and theology, it does not aim to evaluate religious convictions, but studies the historical experience of the relationship between society and religion,

religious practice and the role of religion in certain social processes. In principle, it is presented as a totality of three levels of knowledge: theoretical, empirical and methodological. Dealing with issues of civil religion, secularization, the role of religions in the midst of globalization and the so-called of multiculturalism, the contemporary sociology of religion failed to provide a sufficient fund of knowledge (or it was not properly explained, affirmed and accepted) that would help in terms of its content to better general understanding between confessions, nor did it provide scientific answers to the question of how to reduce the process of radicalization of young believers by subjective or systematic abuse of certain interpretations of belief (parts of religious texts) or to cancel it completely.

The foundations of the modern general theory of conflicts in capitalism, as a multidisciplinary science, were laid by Karl Marx through the elaboration of the teaching on class contradictions and the legitimate development of the revolutionary nature of the working class, i.e. the necessity of social changes in capitalist society. The development of modern science has brought new thoughts and postulates. Thus, for example, the mathematical basis of the unique theory of conflicts (abbr. UTC) of the Russian scientist V.A. Svetlova consists of concepts, theories and theorems of certain theories needed for the creation and analysis of a research model of conflict. First of all, these are concepts, theories and theorems from probability theory, statement logic, graph theory, game theory in its various variations, etc. We note that conflictology simply does not correspond to any requirement from scientific theories, because it is not able to fully explain and describe contemporary conflicts in the world.

Religious radicalization, extremism and religious security

The turbulence of the modern world, the death of capitalism, the lack of a vision of the near and far future in the West and the ideological vacuum have affected every pore of society, including the major denominations. Differences in vision of the future of the Roman Catholic Church (abbr. RCC) es-

calated after the appointment of the new Pope Francis on March 13, 2013 and his later declared “progressive reforms”. This Church was swept by a wave of abuses by priests, which were reflected in the blessing (teologija.net) of LGBTQI+ persons, in their baptism, “marriage”, cremation, burial of homosexuals, transgenders, etc., acceptance of divorced spouses and other activities of believers previously unacceptable to the Church. Certain parts of the Church went further in an avant-garde manner. For example, the Flemish bishops in Belgium announced a special liturgical rite for the blessing of same-sex “marriages” on September 20, 2022, which only added fuel to the fire that was already burning intensely throughout the church municipalities. For now, the culmination of the “innovation” was certainly at the end of last year, with the adoption of the Declaration “Fiducia Supplicans”(ika.hkm.hr), by the Dicastery for the Doctrine of the Faith. Due to the fact that in 32 African countries homosexuality is a criminal offense and from a religious point of view of principled disagreement with the Vatican, the episcopal councils of African countries (Ghana, Cameroon, Congo, Zambia, Nigeria, Rwanda, etc.) have prohibited their priests from giving blessings to same-sex couples.

The result in Europe of the above-mentioned Declaration was the massive withdrawal of believers with conventional and conservative views from the RCC, but also the public exclusion of almost 100 influential priests and public officials from the ranks of the RCC, from the activities proposed from the very top of the Vatican as an undoubtedly very important spiritual center. A large number of Catholic bishops gathered in the Central Committee of German Catholics (German: ZdK), realizing in time the direction in which the events will lead, created the “Synodal Way” (in German „SynodaleWeg“) movement in 2019 together with their own laity. The proclaimed goal of the action is collective thinking and action on the directions of possible reforms of church teaching and spiritual practices in this Church. From 2020 until today, 5 Assemblies of this spiritual project were organized, whose Resolutions called for: consideration of the teachings of the Catechism on homosexuality, the introduction of female clergy, giving up celibacy, allowing the laity to preach

at masses, etc. Certainly the greatest challenge thrown at the residents of the Lateran Palace was the creation of the Committee of Bishops and Laity with the aim of creating a complex basis for the appointment and work (from 2025) of a permanent body called the "Synodal Council". According to the current thinking, its basic tasks would be related to looking at the perspectives of the RCC, planning actions, responsibility for the church budget and finances and other areas.

In November 2023, Pope Francis sent a letter to German Catholics in which he publicly expressed doubts about the legitimacy of the "Synodal Way" and the "Synodal Council", whose powers could be greater than the Bishops' Conference of Germany (abbr. BCG). Referring to the current canon law, Cardinals Pietro Parolin, head of the Secretariat of the Holy See, Victor Fernandes, as of September 15, 2023, Prefect of the Dicastery for the Doctrine of the Faith, and Roberto Prevo, Prefect of the Dicastery of Bishops, called on the German bishops not to create any body with the laity. For its part, the "Synodal Way" also responded with the public Initiative "We - the Church" and a general call to the bishops to continue working together with the laity and to actively involve them in negotiations with the Vatican. The last negotiations between the Holy See and representatives of the "Synodal Way" were carried out in March 2024 (ika.hkm.hr(a)). Information from Belgium, where in February 2024 the Catholic bishops presented their own manifesto in which they publicly propose the decentralization of decision-making in the RCC, also indicates that such thoughts are not isolated at all. Among the decisions that should be made in the national framework, in their opinion, is the ordination of RCC priests, while their program has a lot of conceptual similarities with the "Synodal Way", which in itself indicates the depth of conceptual differences between the religious center and its periphery. Disagreement with the text of "pastoral mercy", as they often call the mentioned Declaration ("Fiducia-Supplicans"), expressed by numerous bishops from the USA, Latin America,

Asia, Europe (Poland, Ukraine, Hungary³, Greece, etc.). That even within the West there are serious conceptual differences was clear 30 years ago. Thus, the Association of Christian Culture "Fr. Petra Scarta" as early as December 2, 2002, in its famous brochure "Entry into the European Union: lifebelt or kiss of death for Christian Poland?" timely warned its fellow citizens and believers that European integration "will present Polish Catholics with a serious problem of conscience", about which the Polish public was recently reminded by the "Polonia Christiana"(pch24.pl) portal. The authors were convinced that this would cause "damage to the mission that God placed in Poland when he pulled it out of the darkness of unbelief and washed its forehead with water in holy baptism." Even then, the association predicted the "denationalization of the Poles", the de-Christianization of the state and the totalitarian tendencies of left-liberal politicians. (Stremidlovski)

The Anglican Church has already gone through the thorny road of "modernization" of spiritual practice before the RCC. It legalized same-sex "marriage" and implemented other religious "innovations", probably counting on securing new, fresh blood among the LGBTQI+ population and hoping that the departure of conservative believers would be significantly less than the influx of anarcho-liberal understandings. Undoubtedly, it also counted on the political influence that LGBTQI+ supposedly has, especially in Europe, which Britain⁴ apparently still sees in the near future as its ideological and informational, but most importantly at the moment new currency colony.⁵ Above all,

in this direction, the publicly presented offer⁶ of French President Emmanuel Macron, the former Rothschild employee, to establish a French nuclear umbrella over Europe (politika.rs) should be understood. It is nothing but the establishment of an intermediate colonial administration, in which certain centers of influence currently located on the Islands are very skilled. However, when it comes to the Anglican Church, as a rule, the opposite of their plans and expectations happened. In a very short time, it has turned into a confederation of church municipalities, with an extremely uncertain future, because believers continue to switch to other denominations en masse. Such activities as its attempt to “protect” the Ukrainian Orthodox Church (UOC), whose activity the current government in Kyiv wants to completely ban, can hardly help it in improving its image, status in society or increasing the number of believers. Namely, by the proposal of Law no. 8371, introduced again in the Ukrainian parliament (rada.giv.ua; mospat.ru; ria.ru) in mid-April 2024, it was proposed not only a ban on the activities of the oldest and most numerous Christian Church in Ukraine, but even the practice of its religious rites in domestic conditions was criminalized! Seen from the point of view of the functioning of human rights, among which there must be the inviolable right to freedom of religion and the certainly necessary preservation of the principle of the rule of law or its semblance, if it is a colony, the tendency of collective punishment of innocent believers, church municipalities and priests, just because of a subjective fact that a certain political option, even if it was the one currently in power, for some reason does not like their religious confession, is extremely worrying.

Our above-mentioned assessment regarding the social influence of LGBTQI+ in modern society is, in the mildest sense, a serious doubt about their real influence, because this mental illusion is based on the enormous ideological help provided to this category of extremists by private information empires and digital social platforms, also privately owned. Without that systemati-

cally implemented ideological and informational super-help provided by the chrematistics⁷ on a global level, the influence of this population in general would be what it essentially is, very marginal. The truth about them would come to light, that in fact they are extravagant individuals, imprisoned in their very serious mental frustrations, group delusions and serious fears.

Seen from the perspective of the classical understanding of international, national and general security, the main challenge stems from the obvious tendency for the Vatican to bring under its spiritual, but also secular influence, that part of LGBTQI+ and anarcho-liberal persons who are already in power in certain countries (or openly striving towards its conquest), prone to unscrupulous attempts to further radicalize the population, in their country and its immediate environment, gender exclusivity, infanticide (that is, maximum liberalization of abortion), legalization of euthanasia, physical elimination of pensioners, mass gender reassignment and dependence on the pharmaconafia, further disorder of the digital space, illegal trade in human organs, trade in kidnapped children, etc., i.e. from the aforementioned positions of action with extremist ideological positions and practices. It is obvious that the Vatican in its religious expansion, from which it follows as always the influence of the Vatican-state, based on group chrematistics, places an accent on the USA, where the return to the post of President Donald Trump is expected,⁸ through which it is possible to strengthen the influence on the USA and all zones under his ideological, military and financial control.⁹ The bearers of passion in this direction are certainly politicians originating from Latin and Central America, whose popularity among American voters according to official polls is growing significantly, after all, as is the number of

US citizens (and those brought)¹⁰ originating from the aforementioned meridians. According to the latest information, they make up 14.7% of the total number of voters and about 40% of the Catholic population (pewresearch.org)¹¹ in the USA. It is not out of place to point out that Catholics of Latin American origin were faithful voters of the Democratic Party in the past, but the fierce ideological promotion of the essential anti-values of the LGBTQI+ group turned them away from this political option. The main problem with them (anarcho-liberals and LGBTQI+) is that in their narrow perception of reality they are maximally blinded by their totalitarian ideology, alleged personal and group exceptionalism, completely separated from the real life and political will of the vast majority of their fellow citizens, quite obviously diametrically opposed to theirs, being chrematistic in its essence. As we have repeatedly seen in the past few years, they are very susceptible and prone to manipulation, i.e. blatant violation of legal norms and/or generally accepted patterns of behavior and already established religious canons, for the sake of preserving their own and deserved privileges. It is not difficult to make a security assessment of what kind of future awaits us all together if that group of absolutely incompetent and inadequate in terms of life gets the opportunity to influence the use of the US nuclear triad or biological weapons based on a certain genotype. An additional reason for concern at the global level is the fact that what we often call the wise West, although we all see that it no longer has the capacity, human, value, technical, or organizational, does not want to voluntarily leave the leadership position to anyone else, as the USSR

once did, probably in panic fear that colonial standards will be applied to their current and former political leaders and conceptual behind-the-scenes government, which they unscrupulously applied all over the world a few centuries ago. Although we must state that objectively there is no reason for their fear, because on the other side of the ideological barricade are the People.

Although the situation in the world is very complicated and full of challenges, we are all witnessing new attempts at religious radicalization of the population, almost on all meridians, from West Asia, where e.g. in Israel, rumors are spreading that they intend to sacrifice (la-croix.com) 5 heifers with red hair, allegedly for the purpose of creating the basis¹² for the construction of the Third Temple in Jerusalem, to the Baltic, where the Russian Orthodox Church (abbr. ROC) is being systematically expelled, and for its believers in Lithuania from February 2024. In 2010, a political decision forcibly introduced the exarchate of the Patriarchate of Constantinople, allegedly in the form of a spiritual alternative. Religious activists, 36 of them from Jerusalem and the world, signed a Declaration condemning the mentioned intention of sacrificing¹³ and creating conditions not only for a regional, but very likely for a new world war. In the West, no one was studiously interested in the destruction of the ecclesiastical communities of the ROC in the Baltic and the persecution of its believers, after all, as in the area of Eastern Europe and especially Ukraine, which makes the concern more serious.

In the event that the current balance of power in the world is conserved for a certain period of time, it would be expected that other Christian Church-

es would be exposed to pressure to change their spiritual theory and religious rituals in due time. From the Patriarchate of Constantinople, generally known for its chrematistic views (formation of the so-called Ukrainian Orthodox Church, abbr. UOC), and onward. Only from the Serbian Orthodox Church (abbr. SOC) several hundreds of priests knelt or bowed before the leader of the RCC, kissed his hand with the Ring of Captive Souls on it and thus symbolically swore allegiance to him, non-verbally acknowledging his religious infallibility and primacy in the spiritual world. The situation is similar in other Orthodox Churches. All of them can succumb and change their attitudes in one way or another, not only because of the pressure from the Lateran Hill, on which the leader of the Black International sits (including the Venetian Black Nobility and large European landowners), but above all because of the still strong influence of the media with global and regional influence, the property of anarcho-liberal ideological leaders from Western countries. These are the 27 guardians of inclusive capitalism, led by the Vatican, who control 147 institutions (75% of which are banks) and allegedly 40% of the world's income, i.e. a super-core of 1,318 companies and banks, through which they try to control 88% of the planet's population.¹⁴ Along these lines, for and against anarcho-liberal "values" a division has already begun among People on all continents and this conceptual process cannot be stopped or redirected. The global ideological separation will only grow over time, and due to the intolerance and propensity to cause and implement violence on the part of Chrematist conceptualists and those politicians who follow them, numerous local and regional conflicts are possible, on a smaller or larger scale. Regardless of whether we call them hy-

brid wars, asymmetric conflicts, civil wars, conflicts under foreign flags or the like. The main cause of all of the above is **the global ideological division** into those who are in favor of the pro-Western, satanic, bio-info-cogno-to-nano and neo-Nazi option and all others, who are first of all ideologically, mentally and spiritually against it and then with their local or with a common ideology, they fight for freedom from the yoke of all kinds of Western colonialism and parasitism. All those who, for whatever reason, decide to live in ideologically westernized and Hollywoodized territory, i.e. on the private property of transnational companies (abbr. TNC) and transnational companies (abbr. TNB), must be aware in advance that they will have to obey the basic rule from medieval absolutism "Whose realm, his religion."¹⁵ The rest of the world, that is, all those who fight for such a right and live in a territory controlled by a common state or a supranational structure made up of several similar states, will have the option of choosing. How broad it is, is another question, because there will be a multidisciplinary conflict with ideological opponents. Yes, in its essence, before us is again the fight for the Freedom of all those who consider themselves Human.

Individual and group religious security, concept and definition

The average man has always been intrigued by all questions directly related to his well-being, spiritual and material. Among existentially important issues such as healthy food, quality drinking water, a functional family, territory and material resources necessary for life, etc., a significant place alongside personal health, moral values, social status, enlightenment, appreciation, objective opportunities for self-realization, psychological and emotional state and financial independence, certainly has personal and collective security. Together with health, personal and collective security is simply necessary for the successful realization of all the mentioned directions and general success in the listed areas.

Within the group of People, subjective well-being is an influential factor in constructing a positive future for personal and small group psychology. It (psychology of a small group) basically consists of: the history of the group, their customs and traditions, personality and way of acting, personality traits in the group, goals and objectives of their activities, concentration (focus) on joint work, organization of activities and security of the group (physical, informational, religious, ideological, material-technical, etc.) and projections of the expected future. All the mentioned parameters together and their connection with the positive religious cognition of the person and the group can result in mental balance and personal happiness, as the desired result of this complex activity. Achieving a positive result is often prevented by many and diverse influences. In recent times, it has certainly been digital technology with its absolutely unregulated norms and, what is even more dangerous, ideological alienation. From the angle we are now considering, an interesting oxymoron is "digital well-being."¹⁶ We have no doubt that in the digital World, virtual and virulent, there can be no long-term benefits for Man, after all, not even in the quantum World, which is breaking through more and more and intends to cancel digitization soon. Ultimately, everything related to the mentioned areas can be reduced to a basic dilemma: Do we want to develop our own or artificial intelligence (abbr. AI)? Based on the past experience of this civilization, it is obvious that we cannot do both together.

By its essence, individual and group religious security could mean: **A stable state of application of the theory of religious rites in which the protection of the subject (individual, group and society) is maximal and the possibility of harmful consequences and danger to the person, group and society is reduced to an acceptable level risks for everyone (individual, group and society as a whole).**

National religious security

In the Introduction of the document titled - "National Security Strategy" it is defined that: "The national security of the Republic of Serbia is the objective state of protection of its national values and interests from all forms of threats, and the subjective sense of security of the citizens of the Republic of Serbia." (Službeni glasnik br.94, 2019) In addition, paragraph 2 reads: "The National Security Strategy of the Republic of Serbia is the highest strategic document, the implementation of which protects the national values and interests of Serbia from challenges, risks and security threats in all areas of social life." (2019) Paragraph 2, item 9 of this document mentions "ethnic and religious extremism", which appear in certain parts of the territory of the Republic of Serbia and, together with separatist aspirations, as a rule encouraged from abroad, can represent a destabilizing factor in the political and security situation in the Republic. It results from the above that, as a consequence of the process of religious radicalization, religious extremism is undoubtedly one of the important security challenges and threats, and therefore it should be systematically studied and controlled in accordance with the theory of risk management, as far as possible under the given conditions.

It is indisputable that Islamism (Wahhabism, Takfirism (Balkans.aljazeera.net), etc.) implemented in certain structures on the territory of the southern Serbian province of AP Kosovo and Metohija in the last 30 years represents a great threat not only to the national security of the Republic of Serbia, but also a challenge to a group of states and supranational structures, because several hundred religious extremists from the territory of AP K&M died during the wars on the territory of the Syrian Arab Republic (abbr. SAR), the Republic of Iraq and in Afghanistan, formally in the ranks of al-Qaeda, the so-called Islamic State of Iraq and the Levant (abbr. ISIL), Al-Nusra Front, Tahrir al-Sham and other international terrorist groups (abbr. ITG)(slobodnaevropa.org). With the start of a special military operation (abbr. SMO) in Ukraine in 2022, Western and other curators recruited new and used surviving terrorist cadres who were used to intimidate the population in West

Asia (SAR, Iraq, etc.), this time with an emphasis on making war together with Ukrainian religious and political extremists, neo-Nazis and their white world sympathizers and “dogs of war”, against a section of Ukrainian citizens from Luhansk and Donetsk regions, supported by the Armed Forces of the Russian Federation. If we analyze the information from the media, we come to the objective conclusion that together with their tribesmen and ideological comrades from Albania¹⁷ and North Macedonia, the religious extremists from AP K&M represent by far the most numerous group of terrorists in the territory of Ukraine, in percentage terms in relation to the population of those territories, while collectively the Western media have been orchestrating them as “foreign paymasters” for two years now. About the success of the religious and ethnic radicalization of the population in the area of the former SFR Yugoslavia during the second half of the twentieth century and the first two decades of the twenty-first century, the data from the Ukrainian battlefield from June 2022 speak very clearly and precisely. Only from February 24 to June 17 of the same year, a total of 608 religiously and politically radicalized terrorists - so-called mercenaries - arrived in the area of the special military operation (abbr. SMO) in the armed forces of the Russian Federation. In terms of numbers, the largest number of them came

from Croatia 204,¹⁸ from Bosnia and Herzegovina 167, from the southern Serbian province of Kosovo and Metohija (AP K&M) 156, from Macedonia 79 and from Montenegro 2. If we take the number of religious extremists from the mentioned areas and compare it with the population, we come to data that are inherently alarming. The figures unequivocally show that the population in the territory of the republics of the former Yugoslavia is more than 11 times more radicalized than the population in the immediate surrounding countries! (Rakazov & Simeunović, 2024, pp. 106-112) The only ones that can be compared with these infamous data are the information about the unfortunately successful radicalization of Georgian citizens.¹⁹

Based on the above facts, we come to the indisputable conclusion that religious security in the national framework of Serbia can represent a complex, demanding, painstaking, but also in modern conditions, a necessary scientific branch for the studious study of a part of national security. It could essentially deal with teaching practical theology with specialization in researching the future of the leading confessions in the Republic of Serbia and the Helm region, researching the directions of development of new religious opinions and practices in the mentioned territories and their immediate surroundings. Our interest can certainly be represented by new developments in the field of religion beyond the immediate geographical environment, if they affect the citizens of the Republic of Serbia and can represent a source of threat to its security and territorial integrity.

Supranational religious security

The statistics of the Ministry of Defense of the Russian Federation as of March 18, 2024 indicate that a total of 8,112 religious and political extremists came from European countries to Ukraine in order to provide direct assistance to Ukrainian religious extremists and neo-Nazis, i.e. to try to conquer Russia, of which up to the specified date 3,611 killed. Of which: from Poland 2,960 (killed 1,497), Britain 822 (killed 360), Romania 784 (349), France 356 (147), Croatia 335 (152), Bosnia and Herzegovina 207 (90), Albania 193 (87), AP of Kosovo and Metohija 191 (84), Latvia 190 (95), Estonia 190 (85), Lithuania 174 (81), Italy 90 (33), North Macedonia 90 (30), Slovakia 52 (8), Bulgaria 32 (6), Slovenia 5 (-), Greece 4 (1), Montenegro 2 (-), Hungary 8 (-), Serbia 1 (-) and others. 3,051 mercenaries arrived from the countries of both Americas, of which 1,354 were killed: from the USA 1,113 (491), Canada 1,005 (422), Colombia 430 (217), Brazil 268 (136) and others. A total of 1,898 Asian mercenaries came, of which 859 were eliminated. Most of them came from Georgia 1,042, Syria 200 (102), Turkey 188 (62), Azerbaijan 63 (32), Israel 64 (29), Armenia 70 (25), Uzbekistan 70 (15), Kazakhstan 21 (8), Republic of China 7 (1) and others. 249 mercenaries arrived from the African continent, of which 103 were killed. By country: from Nigeria 97 (47), Algeria 60 (28), JAR 35 (14), Senegal 15 (4), etc. a total of 77 hirers came from Australia and Oceania, of which 35 were eliminated: from Australia 60 (25), Indonesia 10 (4) and New Zealand 7 (6). Observed in the total number of 13,387 foreign mercenaries, 5,962 or 52.35% were killed. The above-mentioned statistics speak unequivocally about the success of the process of radicalization of the population on the European subcontinent, in relation to other parts of that continent and other continents in general.

Even more interesting are the statistics shown by the current geopolitical projects in Eastern and Central Europe, that is, in the Caucasus and Central Asia, which in their own way, vividly and objectively show the success of the implementation of religious and radicalization of the population on a national basis in those areas. Thus, 4,963 mercenaries arrived in Ukraine from 12

states (or rather, European colonies of different types) that in the basic version²⁰ unite the Polish plan “Three Seas “ (or “Intermarium”), while 495 “dogs of war” came to the area of the special military operation from the countries that unite the Pan-Turkish and neo-Ottoman geopolitical plan “Road to Great Turan”²¹, that is, 10 times less! Even if we add the pan-Islamic component of mercenaries from Albania,²² North Macedonia, Bosnia and Herzegovina, the southern Serbian province of AP Kosovo and Metohija (so-called Kosovo) and Montenegro, from where 682 mercenaries went to Ukraine (291 were killed), the total number of persons potentially led by neo-Ottoman, pan-Turkish and pan-Islamist ideas is 1,177, which is almost four and a half times less than the number of mercenaries from the potential geopolitical space of the “Intermarium”. Bearing in mind that the mentioned geopolitical projects (relatively speaking Polish and Turkish) were designed, managed and coordinated from one global center of power, we believe that the figure of 6,140 foreign mercenaries (or 45.85% of the total of 13,387), who came to Ukraine based on the ideological activity of this global power center, is particularly interesting. And that only through these two lines of conceptual action, and there were other such ideological directions (eg Islamist, neo-Nazi, pan-Zionist, anarcho-liberal, etc.). (2024, p. 121) Based on this information,

it is possible to conclude that the main tendency of the West in the near future will be to create new and strengthen existing right-wing parties, i.e. to attempt to establish military juntas with an ultra-right-wing ideology, following the examples of Francisco Franco in Spain and Antonio Salazar in Portugal in the 20th century.

Speaking about the state of radicalization in Ukraine, it is important to mention that all armed formations of religious extremists and neo-Nazis are under double ideological control. On one side is the Vatican, as the leader of the Black International, and on the other are certain forces with residence in London, who still relatively well control the ideologies created in the 19th century, above all we are thinking of the nationalism of fictional nations, chauvinism and anarcho-liberalism. Although the neo-Nazi battalions "Azov", "Karpatska Sich", "Kraken", "International Brigade" and others are formally under the Ministry of Defense of Ukraine, they are commanded from the shadows by a foreign power center that, for the sake of ideological identification, created a magazine for them, giving it a very symbolic name - "Black Sun".²³ The situation is similar with the armed formations of Islamists, "Ajdar", "Noman Çelebidžihan" and others formed on the basis of Wahhabist and Takfiri worldviews, which are also ideologically controlled from abroad. Formally from Turkey and covertly from London, which at one time created the "Ikhwan" (al-Ikhwan, translated as "Brothers") on the conceptual basis of the Grand Lodge of England, later renamed the Muslim Brotherhood²⁴ (al-

Ikhwan al-Muslimun), but also other international terrorist organizations. The Muslim Brotherhood is currently in power only in Tripolitania, the western part of Libya, where it survives only with the direct help of NATO.

The fact that all those who, at different levels, stand for the mentioned regional projects, "Intermarium" and "Turan", refuse to understand and come to terms with it, is first of all reflected in their catastrophically poor diagnosis of the situation, both at home and abroad. The essence of their problem is that the engine (capitalism) broke down in their machine, which no longer works and no one can help it, because its biological and ontological time has expired. No agreements, no plans to expand NATO with "North+"²⁵ help, and especially not adding fuel to the fire (weapons and additional military equipment to Ukraine) in the hope that it will expand not only to the East, but also to Central and Western Europe, with which they would try to buy themselves a little more time for the necessary consolidation. The transition to capitalist (read chrematistic) war production under the current conditions is not possible not only in Britain, the USA, Germany, France, but anywhere on this planet where the remnants of financial capitalism dominate.

Mental health and safety in the field of religion

The rule of anarcho-liberal capitalism throughout the planet in the last 30 years was actively accompanied by the mass application of terrorist groups in order to try to intimidate people and continue to parasitize them on various grounds. The number of terrorist attacks around the world is measured in the tens of thousands, and hundreds of thousands, as a rule, innocent people died in them. The death of capitalism, which we are all witnessing and the transition to a new reality, implies the total cancellation of all the principles on which the rule of the liberal pseudo-elite was based. From the

strict introduction of personal responsibility (criminal, political, etc.), to the responsibility of certain groups whose activities systematically undermined international peace and security. Building a new culture and new, healthy relationships in society must be determined by the degree of responsibility for one's actions based on general principles, without any possibility of exclusion.

In the near future, in the territories controlled by the state, there simply must be an obligation²⁶ for a specialist doctor (personal and professional) to register and inevitably report to the competent state authorities a person prone to violence,²⁷ a person with very unstable behavior or an already religiously (or politically) radicalized person, who is under the influence of pseudo-religious texts or certain persons with hidden or open violent intentions can become a danger to their environment or society. Fictional Hollywoodized "human rights" cannot be above the collective right to a safe, prosperous and normal life of all residents of the country.

Also, every clergyman in rallies whose activity is approved on the territory of a given country at the present time must have a strict legal obligation (personal and professional) to immediately report to the competent state authorities any person whom he judges to be prone to violent behavior, religious exclusivity or a person who under certain conditions can be used to commit the crime of terrorism.

The same obligation must exist for all other professions in which preliminary identification of potential terrorists and other perpetrators of serious crimes is possible, one of the consequences of which is serious public disturbance.

From psychologists and pedagogues in primary and secondary schools, teachers to university professors and managers of various work or other collectives. All of them must be aware that it is their duty to society, which has allowed them to achieve their professional goals and which pays them for their work, to help defend the People and our society from the mindless acts of attack by non-people, which will obviously happen even more in the near future.

At this point, let's immediately answer the question or transfer the part of the West and local colonial administrations (abbr. LCA) - Where are their rights? We will not only mention the classic answer - Where are they and who will deal with the rights of those who have become victims of those beasts, who were incited against Humans for the sake of their chrematistic interests? - we already have quite specific arguments. On the one hand, at this moment when we are threatened with existential danger, there can be no blank rights, if all work, social and family obligations have not been fulfilled in a timely manner. On the other hand, all those who ask themselves on their own or publicly: Where are their rights? Must be aware of the fact that this is the turning point of the beginning of the New Time in which they will have to publicly declare whose side they are on. Are they on the side of those who want genocide against humanity,²⁸ or are they on the side of the People? What rules they will have to adapt to, ours or theirs, will depend on their free ideological choice. The time of sitting on two chairs is over and it will most certainly not return in the foreseeable future. At the same time, it is also a conceptual answer about the primacy of the liberal mirage of so-called human rights imposed by force and deception over general national interests, behind which the chrematistic interests of supranational groups and financial terrorists have always been very carefully hidden. Their time is up!

CONCLUSION

The violent terrorist attack in the suburbs of Moscow took place after the successful presidential elections²⁹ in the Russian Federation and the resounding victory of Vladimir Putin,³⁰ who decided that his ideological and political support would not be the existing political parties in the Russian Federation, but participants of the Special Military Operation (abbr. SMO) in Ukraine and that part of the population that actively or passively supports them. A few days before the elections, according to the already tested recipe of October 7, 2023, in Israel,³¹ formally and legally using pseudo-Russian opposition organizations (the so-called Russian Volunteer Corps –abbrev. RVC),³² they tried to devalue it by taking as many hostages as possible in the Belgorod region, which they failed to do thanks to the excellent work of the Russian Services and probable help from the West. Bearing in mind that in his addresses to the citizens of Russia, Putin promised to build conditions for normal life and work, a society with conservative values, i.e. that he

hinted at the possibility of removing the existing Westernized globalist anarcholiberal pseudo-elite, which still partially governs Russia, the reaction of their conceptual protectors from the West was expected. Based on the choice of target and the method of carrying out the attack on the Belgorod region, it can be concluded that the original organizers of the mentioned attack on Israel and the attack on the villages in the Belgorod region may be identical. The failure to carry out the first task (Belgorod region) could, but may not, have been the catalyst for giving the order to carry out a new mass terrorist attack, which under certain conditions can be correlated with the crime committed in "Crocus Hall", for which, judging by the recordings, either there was not enough time to work it out in detail, or it was organized by other persons, less clever and less professionally trained. Following this logic, certain technical failures in the execution of the terrorist attack on March 22 of this year become clearer. First of all, we are referring to certain details: a) if they had already planned to flee from the scene of the crime, it is interesting that the terrorists did not wear masks, even though they must have known that there was video surveillance in the hall, i.e. that every natural person had a mobile phone with them with a digital camera with which they could record them, which greatly simplified their detection and undoubtedly successful arrest, b) after the crime they did not destroy the vehicle in which they came to commit it, although this has become an elementary rule, c) they did not provide the second and the third means of transportation, although the tactics of action dictate it, d) they did not disperse the group, with planned and checked individual lines of departure, which would undoubtedly reduce the possibility of arresting all its members, and d) they did not, in accordance with the mode of operation of Islamicized terrorist groups, remain on crime scene and accepted an armed conflict with the special forces of the Russian Federation until their own death, according to the rules of conducting an alleged jihad, etc.

The brutal murder in “Crocus Hall” of at least 144 citizens of the Russian Federation and the wounding of at least 550 of them³³ should in any case be brought into ideological connection with the announcements of satanic conceptualists in the West³⁴ and their servants in all kinds of colonies, that they will consistently undertake activities to carry out genocide against People and try to reduce the human population to the “golden” 1 billion. It is obvious that they will not give up their intentions voluntarily, on the contrary, but that through attempts to provoke wars (in West Asia, Ukraine, Europe, the Caucasus, Taiwan, etc.), that is, through an attempt to organize a new mass biological poisoning of the planet’s population, such as of the one with Covid-19, to continue with their “planned activities”. In all its beauty, during the planning “pandemic”, the truth came to light that the global liberal pseudo-elite

cannot do anything,³⁵ it simply does not want to organize general security for ideological reasons. This is not foreseen in their program postulates. For them, only personal safety and the safety of the assets they have acquired are important. There is no group security among liberals either, because each of them sees themselves at the top of the food chain, and this fact is confirmed by the cannibalism that has recently started among billionaires.

Synthesizing the information available to us through the media about the heinous terrorist attack on Moscow's Crocus Hall, we would like to state a few facts:

a) there are no serious terrorist attacks without the direct participation of intelligence services with global or at least regional ambitions, transnational companies (abbr. TNC) and banks (abbr. TNB), i.e. governance groups (abbr. GG) primarily in the part of the West (and perhaps as of tomorrow and from other sides), interested in their performance. Without the direct or indirect participation of intelligence services and governance groups (abbr. GG) including a part of chrematistics, there would be no analytical-terrorist groups (abbr. ATG), logistic chains (abbr. LC), or support groups (abbr. SG) for perpetrators of terrorist attacks, nor international terrorist groups (abbr. ITG) such as al-Qaeda, the Nusra Front, Tahrir al-Sham or the so-called ISIL, in all its later variations:³⁶

b) it is not about a new type of terrorist attack (abbr. TA), but about the availability and skill of members of international terrorist groups (abbr. ITG) to use modern technologies, from modern weapons, protective equipment, means of communication, to digital technologies, including cameras for video-registration of the commission of crimes, which was very professionally first observed by the so-called ISIL. We should have no illusions, it is quite

certain that al-Qaeda, the terrorists who attacked Spain³⁷ or Andreas Breivik³⁸ would have used digital technology for video recording of their crimes, if they had had the opportunity, because this fits into the basic requirement of every terrorist attack, and that is to cause fear in the population and try to confuse the ideological opponent;

c) photographs of terrorists from “Crocus Hall” available on the Internet, in which they are standing in front of the black flag of the so-called Islamic states raise **the index finger of their left hand** and point it towards the sky, it unequivocally indicates that they are essentially not Islamic believers, because it is clear to any religiously informed person that the left hand is dirty, i.e. it is the side of the Devil and cannot and must not be associated with God (Allah, may His name be holy!). This conclusion is confirmed by the fact that during the execution of the terrorist attack on March 22, 2024, it was Ramadan and that no orthodox Muslim would dare to commit such a crime after the Friday prayer. If you have this information in mind, it becomes much clearer to you the claims of certain presidents, such as the French President Macron or certain media in the West, that the terrorist attack in “Crocus Hall” was carried out by the so-called ISIL, which by the way, like al-Qaeda, was created by MI6, Mossad and CIA.

g) the method of carrying out the terrorist attack in “Crocus Hall” does not correspond to the stereotype of Islamized fanatics who, armed with explosives, dressed and armed, go to jihad with the infidels, and as a rule are ready to die themselves. By no means diminishing their guilt for the crime, one gets the impression that the general picture is more suitable for a group of ex-

tremists who are ready to kill anyone for money, a passerby on the street or even a close friend, relative, it doesn't matter, what matters to them is the money that they will (perhaps) get for it. Can such persons in 13 or 18 minutes kill 144 people and injure over 550, cause a serious fire and get out of the building, or as in the terrorist attack on October 7, 2023 in Israel, they had "help" from several professional executors for which the core group did not know (nor had to know), the investigation and the time ahead will show. We see the confirmation of this hypothesis in the information that the members of the mentioned terrorist group, after escaping from the scene of the crime, amateurishly sold weapons, 2 automatic rifles and about 500 bullets, bottles with flammable liquid, etc., although they have not yet found a safe place for them, supposedly the border with Ukraine.

d) target selection - "Crocus City Hall" may have been chosen in order to send another message to the Russian leadership gathered around President Putin and to the Russian people, in addition to the first message. It should not be ruled out that these could be the owners of the very facility whose leader Berel Lazar met with Putin on February 9, 2024, the day after the publication of the interview that the Russian president gave to American journalist Tucker Carlson. (politika.rs(a)) There is a hypothesis that part of the diaspora conceptually and financially connected to the City of London intended to get rid of the influence from the Island and this is the reason for the terrorist attack (abbr. TA) on their facility. Viewed in this way, the terrorist attack on "Crocus City Hall" can take on a completely different dimension, close to the confrontation of international criminal groups (abbr. ICG) in which accidental victims were killed and the alleged political message is only a mask to cover the objective principals or, if you will, a legend for masking the objective reason of the terrorist attack. If this hypothesis turns out to be true, then the attack on "Crocus Hall" has no direct connection with the terrorist attack on the Belgorod region.

The state of extremism of persons and/or groups of persons with liberal views on the world is perhaps best described by the situation in which the lawyer of

one of the terrorists in “Crocus City” publicly stated at the first hearing before the Basman Court in Moscow that “his client would accept to defend himself at liberty and that he has no intention of hiding from the judicial authorities”! We think that anyone even remotely normal feels offended by such a stupid proposal, completely disconnected from the reality that unanimously condemns the beasts in human form that shot the children and women in the “Crocus Hall” in the back of the head. The silence of not only the Prosecutor’s Office, but also the Moscow Bar Association and the Bar Association of the Russian Federation, in itself speaks volumes about the current state of that part of society, the degree of Hollywoodization, Westernization and the epidemic of the disease of personal and group exceptionalism of a part of society, i.e. among those who completely undeservedly consider themselves elite, although their immediate environment has never recognized that status.³⁹ Seen from the point of view of the Russian specialist services and judicial authorities in charge of preserving the order established by the Constitution of the Russian Federation, this example raises numerous questions and there are certainly many reasons for concern, because the conceptual opponent from the West has succeeded in infecting a certain percentage of the population with his anarcho-liberal ideology. The fact that there are especially many of them in the state apparatus, public services, educational institutions, and especially among the oligarchs, is of special weight. This brings us to the core of the problem, which is the conflict of conceptions imposed on us or the war of ideologies into which we are all pushed together.

The enormous amounts of information and misinformation to which modern Man is exposed make it imperative for their selection, interpretation and adequate use in a shorter or longer period of time. In this context, it is necessary to form a new branch of the sociology of religion or a type of security (a sub-type of national security) that can be conditionally called **religious security**. Within it, interesting and useful scientific sub-branches could be developed: religious diplomacy, religious law and the economy of religion. We are con-

vinced that in this way they would achieve a lot, not only in understanding the accumulated problems of modern Western society,(Law, 2008, p. 159)⁴⁰ the old and new colonies that are currently under its administration, but also get closer to finding their way into **the New Culture**, which is born in the moments of the end of the three-decade long period that can tentatively be called the “rematch of the Black International”. The same was started on November 2-3, 1989, with the illegal meetings of Mikhail Gorbachev in the Vatican and his signing of certain documents in the waters of Malta, which began the dominance of one ideology, anarcho-liberal and part of the West, formally led by the USA, conceptually guided further by Britain and the Vatican. That era, which could also be called **the dominance of the Maltese Order over the world**, was called into question in 2014 by the Russian-Iranian complex helping the Syrian Arab Republic (abbr. SAR) in the fight with international terrorist groups led by the so-called Islamic State of Iraq and the Levant (abbr. ISIL). It definitely became life-critically threatened by the launch of a special military operation (abbr. SMO) in Ukraine on February 24, 2022, and the rocketing of military targets in Israel by IR Iran (abbr. IRI) on April 14, 2024, as a legitimate response to the silence of the international public and the United Nations (abbr. UN) to the Israeli rocket attack on the Iranian consulate in Damascus on April 1, 2024, when high-ranking officers of the Islamic Revolutionary Guard Corps (IRGC) with diplomatic immunity were killed. The following were killed in the attack: the former commander of the IRI Ground Forces, Major General Mohammad Reza Zahedi, (nytimes.com) his deputy, General Mohammad Hadi Haj Rahimi, and IRGC officers who were in their vicinity: Hossein Amanolahi, Sayed Mahdi Jelalati, Mohsen Sedakat, Ali Agababay and Seyed Ali SalehiRuzbahani, as well as several Syrian and Palestinian citizens. The potential reason for organizing the assassination of the Iranian officers is the alleged preparation of an attack on the naval base

and the major port of Eilat⁴¹ in Israel. According to information available to the public, Zahedi was the main coordinator for the implementation of IRGC activities in the SAR and Lebanon. The fact that after a few days information appeared in the public that the Mossad was allegedly not aware of the operation of Amman and Israel Defense Forces in Damascus is not neglected either.

When it comes to religious security, it is about the studious study of the problem of the subjective interpretation of parts of religions or, if you want, the creation of pseudo-religious texts that can be abused primarily from the point of view of negativist ideology, for the purpose of spreading hate speech, attempts to radicalize the population and the creation of groups or persons of influence with extremist attitudes. When we write this, we do not have in mind only the education of those who will later work in intelligence, counterintelligence, police or anti-terrorist jobs, but also a certain number of diplomats who will be able to deal with the work of such power centers such as the Vatican and London, persons who will know and be able to give positive feedback in the media, on social networks, and through their work in educational institutions and universities, to successfully cope with the increasingly complex challenges of educating and enlightening our children, which our arch-enemy imposes on us in an increasingly harsh form. With this approach to problem solving, not only would the state (and supra-state) apparatus have an adequate professional (personnel) base for selecting employees, but also educational institutions, social organizations and media houses, regardless of their size, could use the same staff. Towards the end, we would like to point out that there is no doubt that with a good selection of the members of the SMO, an adequate number of citizens of the Russian Federation can be selected, whose education, or more precisely, enlightenment and guidance, can form a quality personnel basis for the long-term replenishment of the forces necessary not only for the establishment of religious security, as a specialized part of the state apparatus, but also the personnel so necessary for

the establishment of better understanding and more stable communication between different People, religions and peoples from all meridians. It is simply a modern imperative in the starting process of searching for a common ideology of the People and our mutual harmonization. So all those who look at digital technologies and worry about the transfer of Taiwan's TSMC⁴² microchip manufacturing company to California or create analyzes about the new technological revolution or try to predict how the division of the world on the basis of techno-economic blocs will look, do not understand the main task of the present. It is primarily reflected in finding and mastering **a new ideology, capable of uniting all People**, regardless of their skin color, religion or nationality, into a common global human core directed towards the New Culture. That supertask will be far more important than all the technologies, however futuristic or perhaps financially necessary at the moment, from artificial intelligence to quantum cryptography or the mass application of lasers. All this, including the size of the population supposedly necessary to maintain its own currency zone, will be of lower importance than the identification of the People with their new ideology and its self-proclaimed center of gravity. An auxiliary process in the cohesion of the people will be their spontaneous ideological synchronization on the frequency of the new ideology, the positive results of which will contribute to the preservation of state institutions, necessary for our collective survival and development. In the context of understanding cause-and-effect relationships, it is important to clarify the situation with currency zones, i.e. techno-economic blocs. We are all witnesses that our world is divided primarily on an ideological basis, into those who want or are forced to live in the conditions of nano-bio-info-cogno neo-Nazism (dictatorship of the ultra-right or anarcho-liberals) and all others who do not want it, because the perniciousness of that road on which there is no future is obvious to them. Thanks to media with global influence and social networks, for the first time in known history, **ideological separation** is taking place simultaneously on the entire planet and it **is the**

cause of all other events in modern society. One of the consequences of belonging to different ideologies and conflicts on that basis in certain countries, regions, and even continents will be the division into currency zones and/or techno-economic blocs.

Finally, but not the least important for this paper is the statement of the current state of the implementation of the process of radicalization of the population and what it intends to bring to the area of the subcontinent, known as Europe. The three centers of power, the Vatican, London and Washington are in active, or strategic offensive on all fronts, including religious, ideological and military. All parameters important for the quality of life, progress and well-being are in drastic decline with them and this objective tendency will continue and obviously expand further, because all those who plan and make decisions cannot understand that capitalism has died. On the other side are those who are passive and at this moment are still in strategic defense on all the mentioned fronts, above all the Russian Federation, the Islamic Republic of Iran and the People's Republic of China. The state of the state and their economies is significantly better and healthier than in the West, which is belatedly, but somewhat honestly, recognized by economic analysts in the West.

We believe that it is relevant to make a decision on the question from the Paper hypothesis - **Do we need religious security?**, it is necessary to understand that everything that is happening not only in Europe, but throughout the world, in Western Asia, in the Caucasus, Taiwan and elsewhere, is only an introduction, only a color reconnaissance by a part of the West by which they want to determine the total forces, capabilities, mobility, the state of the fighting spirit and the combat arrangement of the opponent, that is, the total defense forces of the Light. This is a sort of warm-up before the decisive battle between Good and Evil, which in the long term will determine the fate of both People and non-People and contribute to the construction of a New Culture among People. What seems to be ahead of us is a major global and multidisciplinary conflict (basically ideological and conceptual) of transnational corporations (abbr. TNC) and transnational banks (abbr. TNB), whose strik-

ing fist around the world will be private military companies (abbr. PMC) and private police companies (abbr. PPC) with People, who will self-organize on the fly, preserve a functional state and its attributes, for the sake of preserving the human way of life and then for defense in the armed conflict imposed on us with chrematistics and their voluntary slaves. Their concept of creating a neo-feudal society, first in the West and then globally, can begin with the creation of a precariat⁴³ in Western Europe and an attempt to establish a pseudo-feudal system with admixtures of the old and already seen manorial political and chrematistic system based on the rule of the land (ownership or the application of force), supplemented by currency based on the gold standard. Whether their conceptual idea will succeed primarily depends on the state of consciousness of citizens in the countries where such processes will first begin. The authors are of the opinion that sooner or later their plan will experience a complete failure, after all, just like at the time at the crossroads of two social systems, feudal and capitalist, which then began to be created, the plan of the feudalists to return to slave ownership.

The end of the thirty-year war that is currently being waged on the soil of Europe, which began with the bombing of FR Yugoslavia in 1999, will bring the end of the Western-centric era of global hegemony, but also the beginning of a new time and a New Culture,⁴⁴ moving the center of gravity of decision-making from the West to the East. After the death of capitalism and the existing pro-Western civilization, a New Culture comes to this World from the East, starting a new cycle. The peculiarity of our era is the fact that through the struggle for local and regional power, the struggle for the creation of a new form of social system, with its own and recognizable ideology, must be interwoven. This is the primary reason why, first of all, under external pres-

asures and threats, for better quality, long-term and, most importantly, more successful defense of our homes, there will be a unification of the identical or peoples who share the same life values. Our differences, often artificially created, will be suppressed and everything we have in common will prevail, creating a new common frequency of the New Culture. First of all, it will lead to the unification of Russians, Prussians and Persians, that is, all peoples,⁴⁵ nationalities, religious and ethnic groups with whom we live on the same territory and have identical attitudes towards Life, Happiness and the Future.

RELIGIOZNA BEZBEDNOST KAO DEO INTEGRISANOG SISTEMA BILO KOJE NACIONALNE BEZBEDNOSTI, DA LI JE I ZAŠTO NJENO STVARANJE NEOPHODNO?

Sažetak

U poslednjih 30 godina, ceo svet je manje-više izložen procesu verske i ideološke radikalizacije ljudske misli putem različitih medija, čiji je nesporan cilj dovođenje pojedinaca, grupa i delova naroda u stanje ekstremističkog oblika razmišljanja i delovanja u tom pravcu. Po pravilu, koristi se za polarizaciju stavova unutar određene nacije ili države, ali vrlo često i za stvaranje ideološke baze za izvođenje raznih terorističkih napada, čiji broj nekontrolisano raste u svetu. Stvaranje raznih interesnih grupa u postkapitalističkom sistemu ukazuje na nemogućnost liberalizma da obezbedi socijalnu sigurnost. Odsustvo razumevanja između različitih konfesija i naroda nedvosmisleno se nameće kao poseban problem, a u poslednjih nekoliko godina, čak i unutar glavnih konfesija, rastu neslaganja po brojnim i vitalno važnim pitanjima. Sukobi stavova, zapaljiva retorika u medijima koja postaje sve oštrija i očigledni sukobi interesa liderskih grupa unutar vera i između glavnih denominacija mogu dovesti do otvorenih sukoba sa nepredvidivim posledicama, ovog puta na globalnom nivou. Postoji veoma snažan utisak da se ništa ne čini da se pokrene proces boljeg međusobnog razumevanja i da se postojeće tenzije smanje na nivo sa kojeg je moguće voditi razuman dijalog i, što je takođe važno, mirnu koegzistenciju.
